IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND ELEVEN.

AN ACT relating to drains and common sewers in the city of  
Bangor.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Whenever the municipal officers of the city of  
2 Bangor shall deem it necessary for public convenience or  
3 health, that a public drain or common sewer should be con-  
4 structed in, along or across any public way, or through  
5 land of persons or corporations, or in, along or across any  
6 way dedicated for public uses, said municipal officers may  
7 order the same to be constructed and paid for from funds  
8 appropriated by the city for such purposes, and may assess  
9 upon lots or parcels of land benefited by the construction of  
10 such sewers, such sums as may be deemed just and equitable

11 toward defraying the cost of such construction, the whole  
12 of such assessments not to exceed three-fourths of such  
13 cost; and such further proceedings relative thereto shall be  
14 had as are now, or may be hereafter provided in the general  
15 laws of the state.

Sect. 2. The provisions of chapter one hundred fifty-three  
2 of the Public Laws of the state for 1850, approved on the  
3 14th day of June, 1850, at a meeting of the city council of  
4 said city of Bangor specially called for the purpose; and  
5 chapter 717 of the Private and Special Laws of the state  
6 for 1871, entitled "An Act relating to drains and common  
7 sewers in the cities of Portland and Bangor"; and chapter  
8 242 of the Private and Special Laws for 1887, entitled "An  
9 Act to amend an Act relating to drains and common sewers  
10 in the city of Bangor," and any and all special laws or ordi-  
11 nances or by-laws relating to construction of drains and  
12 sewers, are, so far as relates to said city of Bangor, hereby  
13 repealed and declared to be of no force or effect.

Sect. 3. All sewers heretofore constructed in the city of  
2 Bangor under the provisions of any of the laws specified in  
3 section 2 of this act, or otherwise, or by order of the municipi-  
4 pal officers or the city council of said city, are hereby de-  
5 clared to be and are, legal and lawfully established public  
6 drains and sewers.
