## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to incorporate the Young Men's Christian Associations and the Young Women's Christian Associations organized or to be organized in this State.

Be it enacted by the People of the State of Maine, as follows:
Section I. Whenever any number of persons, residents
2 of the state of Maine, and not less than ten in number, shall
3 desire to organize a Young Men's Christian Association or
4 a Young Women's Christian Association for the support and
5 maintenance of lectures, sermons, libraries, reading rooms,
6 social and religious meetings and the moral and physical
7 improvement of the youths, young men and young women of
8 any county of this state, such persons shall make, sign and
9 acknowledge before any officer having a seal and authorized

10 to take the acknowledgment of deeds in this state, and file 11 in the office of the secretary of state and the office of the 12 register of deeds in the county in which such association 13 shall be located, a certificate in writing, in which shall be 14 stated the name of the association, the objects for which it 15 is formed, the number of directors and the names of the 16 directors selected for the management of the business and 17 prudential concerns for the first year of its existence. Upon 18 complying with the foregoing conditions, any such associa-19 tion shall be and become a corporation fully organized for 20 the purpose of carrying out the objects of its organization.

Sect. 2. Any corporation formed under the provisions of 2 this act shall have and possess all rights, powers and privi-3 leges given to corporations by the common law, to sue and 4 be sued, to borrow money and secure the payment of the 5 same by notes, bonds and mortgages, upon their personal 6 and real property, and to rent, lease, purchase, hold, sell 7 and convey such personal and real property as may be nec-8 essary and proper for the purpose of erecting buildings and 9 for other proper objects of any such corporation. Such 10 corporation shall have the power to accept bequests and 11 donations of real estate and personal property, and to hold 12 the same, and to use the income and profits.

Sect. 3. The incorporators of any such association shall, 2 within thirty days after the filing of the articles of incorpo-3 ration, as herein provided, meet and elect trustees, who shall 4 hold their offices for one year and until their successors are

5 elected and gualified. The title to all real estate and per-6 sonal property owned by such association shall vest in said 7 trustees, and said trustees shall have the possession, control 8 and care of all the real and personal estate of such corpoo ration. Said trustees shall execute all conveyances, leases. 10 bonds and other obligations of said association, and which II they shall be ordered, authorized and directed to execute by 12 the board of directors of said association. Said trustees 13 shall be responsible for the safe keeping of the real and 14 personal estate of said association and for the care and pro-15 tection thereof, and may, if the board of directors deem it 16 necessary, be required to give bonds in such amounts as 17 fixed by the board of directors. Any Young Men's Chris-18 tian Association or Young Women's Christian Association 19 heretofore organized now owning or holding real estate may 20 accept the provisions of this act by a vote of two-thirds of 21 the board of directors, trustees, or other governing body of 22 said association, and upon the acceptance of this act all the 23 real and personal estate of such association shall immedi-24 ately become vested in the trustces elected under the pro-25 visions of this act. Upon every election of trustees as afore-26 said, such association shall cause a certificate of said elec-27 tion containing the names of said trustees and the date of 28 their election to be filed and recorded in the office of the 29 recorder of said county where said association is located. 30 But no failure on the part of said association or the directors 31 thereof to elect trustees shall vacate the office of any trustee 32 heretofore elected.

Sect. 4. Such corporation shall elect directors from the 2 members thereof at such times and places, and for such 3 periods as may be provided by the by-laws, and they shall 4 have the management and control of the affairs of the asso-5 ciation. Said directors shall have the right to adopt a con-6 stitution and all necessary by-laws for the direction and 7 regulation of the affairs of such association, and to provide 8 how the same may be changed and amended.

Sect. 5. No such corporation shall declare a dividend or 2 make any distribution of its corporate property or earnings, 3 nor shall it be allowed to engage in any business or enter-4 prise, other than the work of said association, but the whole 5 income and revenue of such corporation shall be expended 6 in carrying out the objects of its formation.

Sect. 6. The organization, acts and proceedings of any 2 Young Men's Christian Association or Young Women's 3 Christian Association heretofore organized under any law 4 of this state is and the same are hereby legalized and made 5 valid, and said associations declared to be legally and regu-6 larly incorporated, but nothing in this act shall affect pend-7 ing litigation, but the same shall be determined the same as 8 if this act had not been passed.

Sect. 7. All laws and parts of laws in conflict with the 2 provisions of this act are hereby repealed.
