STATE OF MAINE

RESOLVE to amend article 22 of the Constitution, relating to cities of forty thousand inhabitants or more to increase the municipal indebtedness to seven and one-half per centum.

Resolved: That the following amendment to the Consti-2 tution of this State be proposed for the action of the legal 3 voters of this State in the manner provided by the Consti-4 tution, to wit, Article twenty-two of said Constitution, lim-5 iting municipal indebtedness, is hereby amended by insert-6 ing after the word "town" in the first line thereof, the fol-7 lowing words 'having less than forty thousand inhabitants, 8 according to the last census taken by the United States' and 9 by inserting after the word "however" in the fourth line, the 10 following words 'that cities with a population of forty thou-11 sand or more, according to the last census taken by the Unit-12 ed States, may create a debt or liability which single or in 13 the aggregate, with previous debt or liability, shall equal sev-

14 en and one-half per centum of the last regular valuation of 15 said city, that the debt of said cities of forty thousand inhab-16 itants, or over, shall not be increased in any one year, to a 17 greater amount than one quarter of one per cent of said 18 cities assessed valuation, and provided further,' and by add-19 ing the words 'This resolution shall not be construed to apply 20 to the city of Augusta, which is hereby declared to be forever 21 the seat of government of this State, when it reaches the pop-22 ulation of forty thousand,' so that said article, as amended, 23 shall read as follows:

'No city or town having less than forty thousand inhabit-25 ants, according to the last census taken by the United States, 26 shall hereafter create any debt or liability, which single or 27 in the aggregate, with previous debts or liabilities, shall ex-28 ceed five per centum of the last regular valuation of said city 29 or town; provided, however, that cities having a population 30 of forty thousand or more, according to the last census taken 31 by the United States, may create a debt or liability which 32 single or in the aggregate, with previous debts or liabilities, 33 shall equal seven and one-half percentum of the last regular 34 valuation of said city, that the debt of said cities of forty 35 thousand inhabitants or over, shall not be increased in any 36 one year, to a greater amount than one-quarter of one per 37 cent of said cities assessed valuation, and provided further, 38 that the adoption of this article shall not be construed as 39 applying to any fund received in trust by said city or town, 40 nor to any loan for the purpose of renewing existing loans, 41 or for war or to temporary loans to be paid out of the money
42 raised by taxes during the year in which they were made.
43 This resolution shall not be construed to apply to the city of
44 Augusta, which is hereby declared to be forever the seat of
45 government of this State, when it reaches the population of
46 forty thousand.

Resolved: That the aldermen of cities, the selectmen of 48 towns and the assessors of the several plantations in this 49 State, are hereby empowered and directed to notify the 50 inhabitants of their respective cities, towns, or plantations, 51 in the manner provided by law, to vote at a meeting to be 52 held on the second Monday of September in the year one 53 thousand nine hundred and eleven, upon an amendment 54 proposed in the foregoing resolution, and the question shall 55 be: 'Shall the constitution be amended as proposed by reso-56 lution of the legislature providing that towns having a pop-57 ulation of forty thousand inhabitants or more, according to 58 the last census taken by the United States, be permitted to 59 create a debt or liability which single or in the aggregate 60 equals seven and one-half per centum of its last regular val-61 uation and that the increase in amount of debt be no greater 62 than one-quarter of one per centum of any cities assessed 63 valuation in any one year, and the inhabitants of said city, 64 town, or plantation shall vote by ballot on said question, 65 those favoring the amendment voting 'Yes' and those oppos-66 ing voting 'No' upon their ballots, and the ballots shall be 67 received, sorted, counted and declared in open ward, town

68 and plantation meetings and lists of the votes so received 69 shall be made and returned to the office of the Secretary of 70 State in the same manner as votes for governor and members 71 of the legisalture, and the governor and council shall count 72 the same and make return to the next legislature, and if it 73 shall appear that a majority of the votes are in favor of the 74 amendment, the constitution shall be amended accordingly.

Resolved: That the secretary of State shall prepare and 76 furnish to the several cities, towns, and plantations, ballots 77 and blank returns in conformity to the foregoing resolves 78 accompanied by a copy thereof.'
