#### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to amend Chapter 481 of the Private and Special Laws of 1893, entitled An Act to Incorporate Sebago Improvement Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section 2 of said act is hereby amended by

- 2 striking out the word "twenty" in the second line thereof,
- 3 and substituting therefor the word 'fifty,' so that said sec-
- 4 tion 2 as amended shall read as follows:
- 'Sect. 2. The capital stock of said corporation shall be 6 fifty thousand dollars.'
  - Sect. 2. Section 3 of said Act is hereby amended by strik-
- 2 ing out all of said section and substituting therefor the fol-
- 3 lowing: 'Said corporation is hereby required to maintain

4 the water in the Songo River and its locks between Sebago 5 Lake and the Bay of Naples in the County of Cumberland 6 at a depth of at least four feet and six inches from May 7 first to June fifteenth of each year and five feet and four 8 inches from June fifteenth to September fifteenth of each 9 year, and four feet and six inches from September fifteenth 10 to November first of each year, and that any lock or locks 11 now or hereafter constructed shall be made at least one 12 hundred and ten feet long and twenty-six feet wide in the 13 clear, and for this purpose it shall widen, deepen and remove 14 obstructions from said river, its mouth, source and ap-15 proaches, and construct such dams, locks, breakwaters and 16 piers as may be necessary to carry out the requirements of 17 this Act: Provided, however, that any dams built or main-18 tained by said corporation shall contain sluice-ways for logs. 19 Provided, however, that the enlargement of Songo Lock 20 need not be completed before June 15th, 1912'; so that this 21 Section 3 as amended shall read as follows:

'Sect. 3. Said corporation is hereby required to maintain 23 the water in the Songo River and its locks between Sebago 24 Lake and the Bay of Naples, in the County of Cumberland, 25 at a depth of at least four feet and six inches from May 26 first to June fifteenth of each year and five feet and four 27 inches from June fifteenth to September fifteenth of each year and four feet and six inches from September fifteenth 29 to November first of each year, and that any lock or locks 30 now or hereafter constructed shall be made at least one

31 hundred and ten feet long and twenty-six feet wide in the 32 clear, and for that purpose it shall widen, deepen and remove 33 obstructions from said river, its mouth, source and ap-34 proaches, and construct such dams, locks, breakwaters and 35 piers as may be necessary to carry out the requirements of 36 this Act. *Provided*, however, that any dams built or main-37 tained by said corporation shall contain proper sluice-ways 38 for logs. *Provided*, however, that the enlargement of Songo 39 Lock need not be completed before June 15th, 1912.'

Sect. 3. Section 5 of said Act is hereby amended by strik2 ing out the word "contemplated" in the first line and sub3 stituting therefor the word 'required,' and by adding after
4 the word "ninety-one" in the last line, the following: 'Pro5 vided, however, that if to carry out the requirements of this
6 Act it shall be necessary to build an additional lock at or
7 near the mouth of Songo River, the said corporation may
8 demand and receive an extra toll of fifty cents (50c.) for
9 each passage through said lock from all steamboats and
10 other boats and vessels during such time as it is necessary
11 to use said lock to maintain the water in Songo River at
12 the depth required by this Act.' So that said Section 5 as
13 amended shall read as follows:

'Sect. 5. After the improvements required by this Act 15 shall have been made in said river, its mouth, source and 16 approaches, the said corporation may demand and receive 17 reasonable tolls for passage through its locks of steamboats 18 and other boats and vessels, but not to exceed the tolls in

19 force in the year eighteen hundred ninety-one; *Provided*, 20 however, that if to carry out the requirements of this Act 21 it shall be necessary to build an additional lock at or near 22 the mouth of Songo River, the said corporation may demand 23 and receive an extra toll of fifty cents (50c.) for each pas-24 sage through said lock from all steamboats and other boats 25 and vessels during such time as it is necessary to use said 26 lock to maintain the water in Songo River at the depth re-27 quired by this Act.'

Sect. 4. This Act shall take effect when approved.
