# STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to create a stallion registration board.

Be it enacted by the People of the State of Maine, as follows: Shall Secure a License.

Section I. Every person, firm or company standing or 2 using any stallion or jack for public service in this state, 3 shall cause the name, description and pedigree of such stal-4 lion or jack to be enrolled by a Stallion Registration Board, 5 hereinafter provided for, and shall secure a license from 6 said board as provided for in section 4 of this set. All en-7 rollment and verification of pedigree shall be done by said 8 board.

## Stallion Registration Board.

Sect 2. In order to carry out the provisions of this act,

2 there shall be constituted a Stallion Registration Board, 3 whose duty it shall be to verify and register pedigree; to 4 employ one or more competent graduate veterinarians to 5 make examination of the stallions for soundness, at one or 6 more points in each county in the state; to pass upon cer-7 tificates of veterinary examinations, to issue stallion license 8 certificate; to make all necessary rules and regulations; and 9 to perform such other duties as may be necessary to carry 10 out and enforce the provisions of this act.

#### Member Stallion Registration Board.

Sect. 3. The Stallion Registration Board shall be com-2 posed of the Professor of Veterinary Science at the Uni-3 versity of Maine, the Professor of Animal Industry at the 4 University of Maine and the Commissioner of Agriculture 5 who shall be secretary and executive officer of this board. 6 This board shall be authorized to employ such assistance as 7 they find necessary to carry out the provisions of this act.

### To Secure License Certificate.

Sect. 4. In order to secure the license certificate herein 2 provided for, the owner shall apply for such to the Stallion 3 Registration Board, after the stallion or jack has been ex-4 amined for soundless. The owner of such stallion or jack 5 shall furnish to the Stallion Registration Board the veteri-6 nary certificate, and book registry certificate of pedigree of 7 the stallion or jack, and all other necessary papers relating 8 to his breeding and ownership. Upon verification of pedi9 gree and certificate of breeding a stallion or jack certificate 10 shall be issued to the owner.

Sect. 5. The presence of any one or more of the following 2 named diseases shall disqualify a stallion or jack for public 3 service except such stallions or jacks as were in public use 4 or held for sale for public service at the tme of the enact-5 ment and passage of this act; such diseases or unsoundness 6 hereby defined as infectious, contagious or transmissible dis-7 eases or unsoundness for the purpose of this act: Cataract, 8 amaurosis, laryngeal hemiplegia (roaring or whistling), 9 chorea (St. Vitus dance, crampiness, shivering, spring-10 halt) bone spavin, ringbone, sidebone, glanders, farcy, mal-11 adie de coit, urethral gleet, mange, melanosis and curb when 12 accompanied by curby hock. The Stallion Registration 13 Board is hereby autorized to refuse certificate of enrollment 14 to any stallion or jack affected with any one of the diseases 15 specified, and to revoke previously issued stallion license cer-16 tificate of any stallion or jack found on examination to be 17 so affected, except stallions or jacks in the state at the time 18 of the enactment and passage of this act.

#### Disease or deformity of stallion or jack.

Sect. 6. No stallion or jack shall stand for public service 2 in the State of Maine which is deformed or so badly dis-3 eased as to be in the opinion of the Stallion Registration 4 Board wholly unfit for breeding purposes, and said board 5 is hereby authorized to refuse license certificate and regis-6 try for said animal.

Sect. 7. No stallion or jack shall stand for public service 2 in the State of Maine who is so deformed or faulty in con-3 formation as to be in the opinion of the Registration Board 4 wholly unfit for breeding purposes, and in the case of any 5 trotting bred stallion a certificate may be refused because 6 of inferior size, if in the opinion of the Stallion Registration 7 Board, it should not be issued. If the horse is pacing bred, 8 and is less than 15-1 (fifteen hands one inch) in height, he 9 shall have a standard record before receiving a license.

## Granting temporary licenses in cases of emergency.

Sect. 8. The Stallion Registration Board is authorized in 2 case of emergency to grant temporary license certificates 3 without veterinary examination upon the receipt of an affida-4 vit of the owner to the effect that to the best of his knowledge 5 and belief said horse or jack is free from infectious, con-6 tagious or transmissible disease or unsoundness. Tempo-7 rary license certificates shall be valid only until veterinary 8 examination can reasonably be made.

Stallions or jacks in the state previous to the passage and 10 enactment of this law shall have described in their license 11 certificate any hereditary disease or unsoundness referred 12 to in section 4 of this act.

Sect. 9. No stallion or jack which is not pure bred shall be 2 imported into this state for breeding purposes.

Sect. 10. No stallion or jack less than three years old that 2 is neither pure bred nor grade shall be granted a license.

Posting of license certificates.

Sect. 11. The owner of any stallion or jack standing for 2 public service in this state shall post and keep affixed during 3 the entire breeding season copies of the license certificates of 4 such stallion or jack, issued under the provisions of this act, 5 in a conspicuous place upon the main door leading into the 6 stable or building where said stallion or jack stands for pub-7 lic service. Said copies shall be printed in bold face and 8 conspicuous type, not smaller than small pica, especially the 9 words "pure bred," "grade," etc.

#### Form for license certificate.

Sect. 12. The license certificates issued after proper exam-2 ination for a stallion or jack whose sire and dam are of pure 3 breeding and the pedigree of which is registered in a stud 4 book recognized by the United States Department of Agri-5 culture, shall be in the following form:

16 been examined by the veterinarian appointed by the Stallion
17 Registration Board, and is reported as free from infectious,
18 contagious or transmissible diseases or unsoundness (or is
19 affected with .....) and is licensed to stand for public
20 service in the State of Maine.

The license certificate issued after proper examination for 24 a stallion or jack whose sire or dam, but not both, is of pure 25 breeding, shall be in the following form:

LICENSE CERTIFICATE OF GRADE STALLION OR JACK.

The above named stal-36 lion or jack has been examined by the veterinarian appoint-37 ed by the Stallion Registration Board and is reported free 38 from infectious, contagious or transmissible diseases or 39 unsoundness (or is affected with .....) and is 40 licensed to stand for public service in the State of Maine.

Advertising by owner of jack or stallion.

Sect. 13. Every bill, poster or advertisement, except news-2 paper advertisements, issued by the owner of any stallion or 3 jack licensed under this act, or used by him for advertising 4 such stallion or jack, shall contain a copy of his license cer-5 tificate and shall not contain illustrations, pedigrees, or other 6 matter that is untruthful or misleading.

Sect. 14. Newspaper advertising shall contain the num-2 ber and date of license, the words "pure bred," "cross bred" 3 or grade as the case may be, and shall not contain illustra-4 tions, pedigrees or other matter that is untruthful or mis-5 leading.

Fee for licensing.

Sect. 15. A fee of fifteen dollars (\$15.00) shall be paid 2 to the secretary of the Stallion Board for the veterinary ex-3 amination and enrollment of each pedigree and the issuance 4 of a license certificate in accordance with the breeding of 5 the stallion as above provided. A fee not exceeding two 6 dollars (\$2.00) shall be paid annually for the renewal of the 7 pedigree certificate and service license. Stallions or jacks 8 shall be examined every three years, until ten years of age, 9 and after the first examination shall be exempt from exam-10 ination at ten years of age and over.

Transfer of license.

Sect. 16. Upon a transfer of the ownership of any stallion 2 or jack licensed under the provisions of this act, the license

3 certificate may be transferred by the secretary of this board
4 to the transferee upon the submittal of satisfactory proof of
5 such transfer of ownership and upon the payment of one
6 (\$1.00) dollar.

#### Violation of provisions.

Sect. 17. Any person or persons knowingly or willingly 2 violating any of the provisions of this act shall be punished 3 by a fine of not less than fifty dollars (\$50.00) nor more 4 than two hundred dollars (\$200.00) or by imprisonment for 5 not less than thirty days or more than six months, or by 6 fine and imprisonment for each offence.

### Use of funds recovered from violations, etc.

Sect. 18. All fees provided by this act and all penalties 2 and costs recovered from violation of any provisions of this 3 act shall be paid into the state treasury to be kept as a fund 4 for the use of the Stallion Registration Board in the en-5 forcement of this act. Any funds not so used shall be used 6 to publish reports or bulletins containing lists of stallions 7 examined; to encourage the horse and mule breeding inter-8 ests of this state; to disseminate information pertaining to 9 horse breeding, and for any other such purposes as may be 10 necessary to carry out the purposes and enforce the pro-11 visions of this act.

## Report of Board.

Sect. 19. It shall be the duty of this board to make annual 2 report, including financial statements, to the governor of the

3 state, and all financial records of said board shall be subject4 to inspection at any time by the State Auditor.

Sect. 20. All acts and parts of acts in conflict with this 2 act are hereby repealed. This act shall take effect on Sep-3 tember first, next after passage and approval.
