STATE OF MAINE

RESOLVE in favor of the State School for Boys.

Resolved, That there be and are hereby appropriated for 2 and in behalf of the State School for Boys the following 3 stums and for the following purposes, namely: For the year 4 nineteen hundred and eleven, for current expenses, thirty-5 six thousand dollars; for ordinary repairs and improvements, 6 one thousand dollars; for providing homes for boys and vis-7 iting boys out on parole, five hundred dollars; for painting, 8 five hundred dollars; for improvement of root cellar, three 9 hundred dollars; for plumbing Farrington and Wentworth 10 cottages, fifteen hundred dollars; for insurance premiums 11 on State School property for term of three years, thirteen 12 hundred and sixty dollars.

Total, forty-one thousand one hundred and sixty dollars.

SENATE-No. 190.

For the year nineteen hundred and twelve, for current ex-15 penses, thirty-five thousand dollars; for ordinary repairs 16 and improvements, one thousand dollars; for providing 17 homes for boys and visiting boys out on parole, five hun-18 dred dollars; for painting, five hundred dollars.

Total, thirty-seven thousand dollars.

STATEMENT OF FACTS FROM THE COMMITTEE.

For appropriation for nineteen hundred and eleven committee decided that thirty-six thousand dollars would be sufficient for current expenses, that one thousand dollars would furnish repairs and improvements, that five hundred dollars would be adequate for painting, that fifteen hundred dollars would be sufficient for repairs and improvement in plumbing, that the committee has an estimate from insurance companies of one thousand three hundred and sixty dollars for insuring State School buildings for three years for ninety-five thousand dollars insurance, a list of the buildings and amount of insurance on same attached.

For appropriation for nineteen hundred and twelve committee decided that thirty-five thousand dollars would be sufficient for maintenance, for ordinary repairs and improvements one thousand dollars, for painting five hundred dollars.
