STATE OF MAINE

RESOLVE providing for the payment of certain deficiencies,
accrued prior to January one, nineteen hundred and eleven.

Whereas, the various deficiency items comprised in this resolve are long overdue and further delay in the payment thereof will occasion great inconvenience to the departments of state government and to the creditors of the state; and whereas, in the opinion of this Legislature these facts constitute this resolve an emergency measure, which is immediately necessary for the preservation of the public peace, health or safety, now therefore be it

Resolved, that for the purpose of paying the several claims, 2 accounts and demands against the State, accrued prior to, 3 and remaining unpaid on January first, nineteen hundred 4 and eleven by reason of insufficient and lapsed appropria- 5 tions, that there be and hereby is appropriated the sum of 6 three hundred thirty-five thousand six hundred thirty dollars 7 and seventy-two cents, for the year nineteen hundred and 8 eleven for the following purposes:
