## STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND ELEVEN.

AN ACT to amend and extend the charter of the Dover and Foxcroft Water District.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section 2 of chapter fifty-four of the Private

- 2 and Special Laws of the State of Maine for the year one
- 3 thousand nine hundred and five is hereby amended by in-
- 4 serting in the fourth line of said section, after the word "pur-
- 5 chase," the following words: 'and for sprinkling streets
- 6 within the limits of said district,' so that said section shall
- 7 read as follows:

'Sect. 2. Said Dover and Foxcroft Water District is here-

- 9 by authorized to raise money by taxation for the purposes of
- 10 operating, repairing and extending its water works system

11 and for the payment of the debts incurred by its purchase, 12 and for sprinkling streets within the limits of said district, 13 in addition to the purposes now authorized, to be levied and 14 collected in the manner provided by its charter.'

Sect. 2. Section six of chapter fifty-four of the Private 2 and Special Laws of the State of Maine for the year one 3 thousand nine hundred and five is hereby amended by strik-4 ing out the word "forty" in the third line of said section and 5 adding in place thereof the word 'seventy-five,' so that said 6 section as amended shall read as follows:

'Sect. 6. Said Dover and Foxcroft Water District is au-8 thorized to issue its bonds in amount not exceeding one hun-9 dred and seventy-five thousand dollars, for such purposes 10 and on such terms and conditions as it may deem expedient. 11 Said bonds shall have interest coupons attached. Said bonds 12 shall be signed in behalf of said corporation by its treasurer 13 and countersigned by its assessors, and the coupons attached 14 thereto shall be impressed by the fac-simile of the signature 15 of its treasurer. Said bonds shall be a legal obligation of 16 said water district, which is hereby declared to be quasi mu-17 nicipal corporation within the meaning of section fifty-five, 18 chapter forty-six of the Revised Statutes and all the pro-19 visions of said section shall be made applicable thereto. Said 20 bonds, it is hereby declared, shall be public funds of the 21 State of Maine, within the meaning of section one of chapter 22 one hundred and sixty-one of the Public Laws of one thou-23 sand eight hundred and ninety-five.'

Sect. 3. The Dover and Foxcroft Water District is here2 by authorized for the purposes mentioned in its charter to
3 take and hold sufficient water of Garland Pond situated in
4 Foxcroft and Sebec in the county of Piscataquis and Salmon
5 Pond in the town of Guilford in said county or either of
6 them, and may raise the waters of said ponds or either of
7 them by dams at the outlets thereof to such a height as said
8 district may deem expedient, and may take and hold by pur9 chase or otherwise, any land or real estate necessary for
10 erecting dams and flowage caused thereby, power, reser11 voirs, or for preserving purity of the water and water sheds,
12 and for maintaining a way from the public highway to said
13 ponds and for laying and maintaining aqueducts for con14 ducting, discharging, distributing and disposing of water.

## SENATE REPORT.

The Committee on Interior Waters to which was referred the bill, entitled "An Act to amend and extend the charter of the Dover and Foxcroft Water District," have had the same under consideration and ask leave to report the same in a new draft and that it be referred to the Committee on Judiciary.
