## STATEMENT OF FACTS.

*To the Senate and House of Representatives, in Legislature assembled:*

This resolve in favor of the Town of Moscow is for the purpose of reimbursing said town for money which they have expended for state paupers, and which has never been allowed and paid to said town by the state.

In the years of 1902 and 1903, Ed. Crotto, of Moxie Core, in the County of Somerset, an unorganized township, Floyd Young, and some others, of The Forks Plantation, fell in want and in need of immediate assistance, which assistance, in the way of clothing and supplies, was furnished to said paupers by said Town of Moscow to the extent of four or five hundred dollars. The State authorities have allowed and paid for the greater part of these bills. In fact, all of the money expended by the Town of Moscow for these state paupers, with the exception of a balance of \$57.73, which was due and owing to M. L. French, of North Anson, who left this claim with Hon. Augustine Simmons for collection, to whom this amount was paid in the month of March, 1909, as appears by the order on the Town Treasurer of Moscow, dated March 8, 1909, which is hereunto attached, has been repaid to said town by the State. This amount of \$57.73, which was paid by said town of Moscow, for supplies furnished the above mentioned state paupers, in March, 1909, has never been repaid to said town, and it is this amount which said town of Moscow asks may be granted to it by way of resolve.
