AN ACT to incorporate the Kennebec Gas and Fuel Company.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Carroll W. Abbott, L. E. Thayer, Mark J. 2 Bartlett of Waterville in the county of Kennebec and State 3 of Maine. Silas T. Lawry of Fairfield in the county of 4 Somerset and State of Maine. John H. Lancaster of Skow- 5 hegan in said county of Somerset and Wm. Kuemmerle, Jr., 6 of Philadelphia in the State of Pennsylvania, their asso- 7 ciates, successors and assigns are hereby made a body cor- 8 porate by the name of the Kennebec Gas and Fuel Com- 9 pany.

Sect. 2. The purposes of said corporation are the manu- 2 facturing, selling, distributing and supplying of gas for

3 heating, lighting, fuel, manufacturing and mechanical pur-  
4 poses in the city of Waterville and the towns of Oakland,  
5 Vassalboro, Winslow, Benton, Fairfield and Skowhegan,  
6 with all the rights, powers and privileges, and subject to all  
7 the restrictions and liabilities, by law, incident to corpora-  
8 tions of similar nature; also to sell and dispose of the by-  
9 products incident to the manufacture of gas.

Sect. 3. The capital stock of said corporation shall be five  
2 hundred thousand dollars, divided into shares of one hun-  
3 dred dollars each. Said corporation may hold real and per-  
4 sonal estate necessary and convenient for its purposes afore-  
5 said.

Sect. 4. Said corporation shall have the right to manu-  
2 facture, sell and dispose of gas in the city of Waterville  
3 and the towns of Oakland, Vassalboro, Winslow, Benton,  
4 Fairfield and Skowhegan and to lay gas pipes in any of the  
5 public streets and highways in said municipalities and to  
6 take up, replace, and repair the same, and to build, con-  
7 struct and maintain, fixtures, reservoir, gas holders, and  
8 other things requisite, proper and convenient for the man-  
9 ufacture, distribution and sale of gas in said municipalities,  
10 subject to the permission of the municipal officers of said  
11 municipallties and such reasonable restriction as they may  
12 lawfully impose, and to the general laws of the state rela-  
13 tive thereto.

Sect. 5. The city of Waterville and the towns of Oakland,  
2 Vassalboro, Winslow, Benton, Fairfield and Skowhegan or

3 any manufacturing or machine company having its place of  
4 business in said municipalities may take and hold stock in  
5 said corporation.

Sect. 6. Said Kennebec Gas and Fuel Company may issue  
2 its bonds upon such rates and time as it may deem expedient  
3 and in such amount as may be required for the objects of  
4 its incorporation and for the purposes authorized by this  
5 act, and secure the same by mortgage upon the franchise  
6 and property of said company.
