STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to authorize the Van Buren Water District to issue bonds.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The Van Buren Water District, in the town of

- 2 Van Buren, in the county of Aroostook and State of Maine,
- 3 is hereby authorized to issue its bonds to an amount not ex-
- 4 ceeding twenty thousand dollars in all, in addition to the
- 5 amount of the bonds of the said Van Buren Water District
- 6 already issued and which have not yet matured, for the pur-
- 7 pose of providing funds for the payment of the amount
- 8 borrowed to take up the bonds which matured on the first
- 9 day of January, 1912.

Sect. 2. The issue of bonds provided for in the preceding

- 2 section may be authorized by a vote of a majority of the 3 legal voters present and voting at any legal meeting called 4 therefor, by virtue of a warrant signed by the trustees of 5 said water district for the time being, containing proper 6 articles, stating the purpose or purposes of said meeting. 7 directed to any constable of the town of Van Buren, residing 8 within the limits of the water district.
- Sect. 3. Except as hereinbefore provided, any and all 2 meetings called for the purpose or purposes contemplated by 3 this act, shall be called and held in accordance with the pro-4 visions governing the calling and holding of town meetings. 5 The clerk of the water district shall be the clerk of the 6 meeting or meetings called in pursuance of this act, and all 7 records relative thereto shall be duly made and attested by 8 him.
- Sect. 4. At any such meeting, a majority of the legal 2 voters of said water district present and voting may author-3 ize its trustees for the time being, to issue bonds in such 4 denominations, signed by them and countersigned by their 5 treasurer, and payable at such time or times, and bearing 6 such rate of interest as such trustees shall deem most ad-7 vantageous for the said water district.
- Sect. 5. The failure or omission by the legal voters of 2 the Van Buren Water District at any meeting called for the 3 purposes mentioned in section one to vote the amount re-4 quired for the purposes contemplated by said section shall

5 not prevent the calling of any other meeting or meetings6 for such purpose until the same shall have been accom-7 plished.
