STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THIRTEEN.

AN ACT to change the name of the Aroostook Trust and Banking Company to Aroostook Trust Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The corporate name of the Aroostook Trust
2 and Banking Company, a corporation created by and organ-
3 ized under the provisions of Chapter four hundred and fifty-
4 seven of the Private and Special Laws of the State of Maine,
5 for the year eighteen hundred and eighty-nine, is hereby
6 changed from Aroostook Trust and Banking Company to
7 Aroostook Trust Company, and said corporation shall here-
8 after be known by the corporate name of Aroostook Trust

9 Company and under the said corporate name of Aroostook
10 Trust Company shall hereafter do and transact all its busi-
11 ness, and bring all its suits, actions and proceedings both at
12 law and in equity.

Sect. 2. Under said corporate name of Aroostook Trust
2 Company said corporation may bring and maintain any and
3 all actions and proceedings both at law and in equity which
4 it could have brought and maintained under said corporate
5 name of Aroostook Trust and Banking Company, if said
6 corporate name had not been changed as provided in sec-
7 tion one of this act, and under said corporate name of
8 Aroostook Trust Company it may be sued. No action or
9 proceeding at law or in equity brought by said corporation
10 under said corporate name of Aroostook Trust Company or
11 against said corporation under said corporate name of Aroos-
12 took Trust Company, shall be abated, discontinued or dis-
13 missed because of said change in said corporate name.

Sect. 3. The aforesaid change of the corporate name of
2 the aforesaid corporation, shall in no way alter, lessen,
3 change or modify the powers, privileges, rights and immu-
4 nities conferred upon and possessed by said corporation un-
5 der the provisions of the aforesaid chapter four hundred
6 and fifty-seven of the Private and Special Laws of the State
7 of Maine for the year eighteen hundred and eighty-nine,
8 and shall in no way change, alter, modify or lessen the du-
9 ties and obligations of said corporation under said chapter
10 of said laws.

Sect. 4. All business, things and acts heretofore done by
2 said corporation under the said name of Aroostook Trust
3 Company and which may hereafter be done by said corpora-
4 tion under said name up to the date this act takes effect,
5 are hereby legalized, ratified, confirmed and made valid.
