AN ACT to legalize the doings of the stockholders of the Aber-  
thaw Construction Company.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. The action of the stockholders of the Aber-  
2 thaw Construction Company, a corporation organized under  
3 and by virtue of the laws of the State of Maine, at a meeting  
4 held on June 18, A. D. 1912, wherein it was voted: "that for  
5 the more convenient transaction of its business, the charter  
6 or certificate of organization of the corporation be and the  
7 same is hereby changed by adding to the purposes of said  
8 corporation stated in said charter the following: the carrying

9 on of any building, contracting, construction, mechanical or  
10 manufacturing business, the development of water powers,  
11 the production and accumulation of electricity and electro-  
12 motive force, by means of water power or otherwise, the  
13 transmission and supply of electricity for light, heat or pow-  
14 er, the manufacture, purchase, use, sale and other disposition  
15 of any articles used in any business hereinbefore described,  
16 the purchase, use, sale, promotion of and dealing in inven-  
17 tions, patented or otherwise, and licenses under patents re-  
18 lating to any such business or articles, the acquisition, own-  
19 ing, mortgaging, pledging and disposition of notes, shares,  
20 stock, bonds, mortgages, debentures and other securities,  
21 obligations, contracts and evidences of indebtedness of the  
22 United States and the several states thereof, municipal, pub-  
23 lic or private corporations, trusts, associations, partnerships  
24 and individuals engaged in or associated together for the  
25 purpose of carrying on any business above stated, the pro-  
26 motion, taking stock in, loaning money to and contracting  
27 with individuals, partnerships, associations or corporations  
28 for the purpose of carrying on any such business, and for  
29 the purposes aforesaid, the acquisition, ownership, improve-  
30 ment, mortgaging, sale, conveyance or other disposition of  
31 real and personal property in the United States and Canada  
32 or elsewhere; excepting that nothing herein authorizes the  
33 business of banking, insurance, a savings bank, trust com-  
34 pany or corporation intended to derive profit from the loan  
35 or use of money, a safe deposit company or the renting of

36 safes and burglar proof and fire proof vaults; and any busi-  
37 ness hereunder may be carried on only in states, countries  
38 and jurisdictions when and where permissible under the  
39 laws thereof and subject to the limitations and restrictions  
40 imposed by such laws," is hereby made and declared legal.

Sect. 2. The record of the certificate of the said action in  
2 the office of the Secretary of State is hereby made and de-  
3 clared a legal record.

Sect. 3. Immediately upon the going into effect of this  
2 act the Secretary of State shall minute on the margin of the  
3 record referred to in Section two hereof a reference to this  
4 act, and he shall thereupon furnish to the clerk of said cor-  
5 poration, a certified copy of the same, with said marginal  
6 reference, who shall cause the said certified copy to be re-  
7 corded in the registry of deeds for the County of Cumber-  
8 land, and who shall pay to the register thereof the sum  
9 of five dollars.
