AN ACT to amend Chapter 217 of the Acts and Resolves of  
nineteen hundred and eleven, increasing the corporate limits  
of the Porter Kezar Falls Village Corporation of Porter.

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Section one of said chapter is hereby amended  
2 as follows: By adding after the word "at" in the eleventh  
3 line the following: 'Also the part of the territory of the  
4 town of Hiram in the county of Oxford embraced within  
5 the following described limits: Commencing at a point on  
6 the town line between the towns of Porter and Hiram twen-  
7 ty-five rods northerly of county road leading through Kezar  
8 Falls Village and South Hiram to Cornish Village, thence

9 easterly and parallel with said road and twenty-five rods  
10 therefrom to westerly line of land of Lewis Gould, thence  
11 southerly on said westerly line to said road and continuing  
12 the same course to the Great Ossipee river, thence westerly  
13 up said river to said town line, thence northerly on said  
14 town line to point begun at, so that when amended said  
15 section shall read as follows:

Section 1. The territory in town of Porter embraced  
17 within the following limits: Beginning at the Kezar Falls  
18 Woolen Co's. dam on the Great Ossipee river, thence north-  
19 erly and parallel with School street in said Kezar Falls vil-  
20 lage to an open drain on southerly part of Wm. Chapman  
21 and Son's land about ten rods north of homestead of Irvin  
22 Mason; thence easterly and southerly by said drain and  
23 Spectacle Pond brook to Hiram line; thence southerly on  
24 said Hiram line to Great Ossipee river; thence westerly on  
25 said river to first mentioned point begun at; also the part  
26 of the territory of the town of Hiram in the county of  
27 Oxford embraced within the following described limits:  
28 Commencing at a point on the town line between the towns  
29 of Porter and Hiram, twenty-five rods northerly of county  
30 road leading through Kezar Falls Village and South Hiram  
31 to Cornish village, thence easterly and parallel with said road  
32 and twenty-five rods therefrom to westerly line of land of  
33 Lewis Gould, thence southerly on said westerly line to said  
34 road and continuing the same course to the Great Ossipee  
35 river, thence weserly up said river to said town line, thence

36 northerly on said town line to point begun at, together with  
37 the inhabitants thereof is hereby created a body politic and  
38 corporate by the name of the Porter Kezar Falls Village  
39 Corporation of Porter with all the rights and privileges  
40 granted by the laws of the state to similar corporations.'

Sect. 2. This act shall take effect if accepted by a major-  
2 ity of the legal voters of the Porter Kezar Falls Village  
3 Corporation and also by a majority of the legal voters of  
4 territory to be annexed on or before July 1, 1914, and F.  
5 E.Stearns and Monroe French or either one of them may  
6 call all meetings of the inhabitants of territory to be an-  
7 nexed previous to the acceptance of this act by posting a  
8 notice, stating the time, place and objects of said meeting,  
9 in at least two public places in said territory, at least seven  
10 days before the time of holding said meeting.
