STATE OF MAINE

RESOLVE, in favor of the town of Nobleboro.

Resolved: That there be paid to the town of Nobleboro 2 out of any funds of the state not otherwise appropriated, the 3 sum of seven hundred and three dollars and sixteen cents, 4 (\$703.16), to reimburse said town for money paid out for 5 the benefit of Annie L. Harris, an insane pauper and in- 6 mate of the Maine Insane Hospital.

STATEMENT OF FACTS.

Annie L. Harris, the insane person committed to the Insane Hospital at Augusta by the town of Nobleboro, in 1892, was married to Calvin B. Harris, at Damariscotta Mills, August 17, 1884.

Calvin B. Harris, her husband, is a native of Nova Scotia. He left Nova Scotia when about twenty years of age and located in Massachusetts. About a year later he went to Portland, Maine, and was employed by the Portland Star Match Co. He remained in Portland about a year, and went from there to Damariscotta Mills, Maine, where he was employed by the same company. He worked at Damariscotta Mills about two years, and then went to Somerville, Mass. About six months later he returned to the Mills when he was married. He remained at the Mills about four months after his marriage, and then removed to Goffstown, New Hampshire. He went from Goffstown to North Ware, New Hampshire, and later removed to Taunton, Mass., where he has since resided.

His wife, Annie L. Harris, was taken insane at said Taunton and was committed to the Taunton Asylum. She improved under the treatment she received at said Asylum, and was later taken by her husband to her mother's at said Damariscotta Mills. She there grew worse and was committed by the town of Nobleboro to the Insane Hospital at Augusta, in 1892, where she has since remained at the support of the said town of Nobleboro. During all the time she has been committed to the Insane Hospital at Augusta, her husband and children have resided in Massachusetts.
