AN ACT permitting the use of Automobiles in the town  
of Eden.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Chapter four hundred twenty of the Private  
2 and Special Laws of 1903 and chapter two hundred forty-  
3 two of the Private and Special Laws of 1911 are hereby  
4 repealed. So much of chapter one hundred thirty-three  
5 of the Private and Special Laws of 1909 as amended by  
6 chapter two hundred seventy-two of the Private and Special  
7 Laws of 1911 as relates to the town of Eden, and all other

8 acts and parts of acts prohibiting or restricting the use of  
9 automobiles or motor vehicles in said town of Eden are  
10 hereby repealed. All by laws and ordinances of said town  
11 of Eden prohibiting or restricting the use of automobiles  
12 or motor vehicles on the town ways, streets or highways  
13 of said town are hereby declared void and of no effect.

Sect. 2. The town of Eden, in the county of Hancock,  
2 and State of Maine, may, at any legal meeting, called by a  
3 warrant containing an article for the purpose, close to the  
4 use of automobiles and motor vehicles the following town  
5 ways and highways within its limits: The Norway Drive,  
6 so called, beginning at Liscomb's Corner, so called, and  
7 extending to the Eagle Lake road near the Young District  
8 schoolhouse; the Breakneck Drive between Hulls Cove and  
9 the Eagle Lake road; the Ocean Drive, beginning at the  
10 bridge at the foot of the hill near the Satterlee property,  
11 at Great Head, and extending to the drive way to the  
12 Country Club, near Otter Cliffs. Any town way or high-  
13 way so closed shall be marked at the entrance thereof by  
14 signboards in large letters "No Automobiles allowed on  
15 this road."

The term "automobile" as used in this section applies to  
17 all motor vehicles propelled by power. For the violation  
18 of this section the town of Eden may vote at said meeting  
19 what punishment shall be inflicted for the violation thereof,  
20 but for the first offense, not over twenty-five dollars and  
21 costs of prosecution; for the second offence, not over

22 twenty-five dollars or thirty days' imprisonment, or both  
23 and costs of prosecution.

The provisions of this section shall not apply to steam  
25 road rollers or motor fire engines used by direction of the  
26 municipal officers of said town of Eden.
