STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND THIRTEEN.

AN ACT to incorporate the Harvey Memorial Crittenton Home.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Sophia Harvey, Charles W. Pillsbury, George
2 L. Crosman, Mary E. Staples, Myra Parcher, Anna P.
3 Woods, Chester D. Emerson, William S. Matthews, Levi
4 Stone, Sarah M. Cragin, Effie Carle, A. P. Milliken, Laura
5 Palmer, W. L. Burleigh, Addison S. Thayer, Frances Mat-
6 thews, Mary E. Hayes, Mrs. R. M. S. Buzzell, Charles H.
7 Prescott, Edward C. Reynolds, their associates and success-
8 ors, are hereby incorporated and made a body politic by the
9 name of the Harvey Memorial Crittenton Home, and by that
10 name may sue and be sued, may have a common seal, and

11 shall have all the immunities and privileges and be subject
12 to all the liabilities of like corporations.

Sect. 2. Said corporation may take, receive, purchase, hold
2 and possess lands and tenements in fee simple or otherwise,
3 and dispose of and sell the same, and may receive of and
4 from all persons disposed to aid its benevolent purposes and
5 grants and devises of real estate, and any donations, sub-
6 scriptions and bequests of money, or other property, to be
7 used for the purpose of establishing and maintaining a hos-
8 pital and refuge home for girls, at Old Orchard, Maine.

Sect. 3. The said corporation shall have the power to make
2 and establish such by-laws and regulations as may be neces-
3 sary for the choice of proper officers, to prescribe their duties
4 and powers and to provide generally for the internal gov-
5 ernment and economy of the hospital and home, such by-
6 laws and regulations, not being repugnant to the constitu-
7 tion of this state.

Sect. 4. The first meeting of said corporation may be
2 called by written notice thereof, signed by any incorporator
3 herein named, served upon each incorporator by a copy of
4 the same in hand, at least seven days prior to the day named
5 therein for such meeting, or by mailing a written notice
6 signed by any incorporator, postage paid, to each of the other
7 incorporators seven days at least before the day of the meet-
8 ing, naming the time, place and purpose of such meeting and
9 at such meeting the necessary officers may be chosen, by-
10 laws adopted and any other corporate business transacted.
