IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND THIRTEEN.

---

AN ACT to amend chapter one hundred and fifty-four of the Private and Special Laws of eighteen hundred and ninety-five as amended by chapter one hundred and fifty-six of the Private and Special Laws of nineteen hundred and eleven relating to the charter of the Wiscasset Water Company.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Chapter one hundred and fifty-four of the Private and Special Laws of eighteen hundred and ninety-five as revived and amended by chapter one hundred and fifty-six of the Private and Special Laws of nineteen hundred and eleven is hereby further amended by inserting after the word "purchase" in Section II the words 'at not exceeding one hundred dollars per share, the total purchase price not to

8 exceed twelve thousand dollars' and by striking out after the  
9 words "Wiscasset Water Company" in said section the  
10 words "to an amount not exceeding twelve thousand dollars  
11 at the market value of said stock at the time when said pur-  
12 chase may be made", so that the section shall read as fol-  
13 lows:

'Sect. 11. The Town of Wiscasset is hereby authorized  
15 and empowered to purchase at not exceeding one hundred  
16 dollars per share, the total price not to exceed twelve thou-  
17 sand dollars, and own stock of the Wiscasset Water Com-  
18 pany, and the person or persons and the Wiscasset Water  
19 Company from whom the said stock may be purchased are  
20 hereby authorized to transfer the same to said town, and the  
21 municipal officers of said town may appoint some person to  
22 vote the stock so purchased as they may direct in all meet-  
23 ings of said Wiscasset Water Company.'

Sect. 2. Section nine of chapter one hundred and fifty-  
2 four of the Private and Special Laws of eighteen hundred  
3 and ninety-five as amended by chapter one hundred and fifty-  
4 six of the Private and Special Laws of nineteen hundred and  
5 eleven is hereby amended as follows: The word "eighteen"  
6 in said section as amended is stricken out and the word  
7 'twenty' inserted, so that the section shall read as follows:

'Sect. 9. This act shall be null and void in twenty years  
9 from the approval thereof unless the corporation shall have  
10 organized and commenced actual construction of its works  
11 under this charter.'
