STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to amend Section ten of Chapter six of the Revised Statutes as amended by Chapter one hundred thirty-five of the Public Laws of 1905, and to amend Section twenty-four of said Chapter six of the Revised Statutes, relating to the regulation and conduct of elections.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section ten of chapter six of the Revised Stat-

- 2 utes, as amended by chapter one hundred thirty-five of the
- 3 Public Laws of 1905, is hereby further amended by striking
- 4 out in said section the words "a blank space shall be left

5 after the name of the candidates for each different office in 6 which the voter may insert the name of any person for whom 7 he desires to vote as candidate for such office," and sub-8 stituting in their stead the following, to wit:-- 'A column 9 marked "Blank Column," with the same list of officers as 10 is contained in the party columns or groups, shall be placed II last on said ballot, and under each office designated shall be 12 left sufficient blank space in which the voter can write the 13 name of such person as he may wish to vote for, if such 14 name is not printed on the ballot; and to the left of each 15 party column or group, in addition to the square at the head 16 of said column or group, shall be placed squares for a cross 17 (x), so that opposite each name and office on the ballot there 18 may be a square in which may be placed by the voter so 19 desiring, the cross (x) as hereinafter provided,' so that said 20 section as amended shall read as follows:—

'Sect. 10. Every general ballot, or ballot intended for the use of all voters, which shall be printed in accordance with the provisions of this chapter, shall contain the names and residences, ward residences in city elections, of all canditates whose nominations for any office specified in the ballot have been duly made and not withdrawn in accordance herewith, and the office for which they have been severally nominated and shall contain no other names except that in case of electors of president and vice-president of the United States, the names of the candidates for president and vice- president may be added to the party or political designation.

32 The names of candidates nominated by any party shall be 33 grouped together upon the ballot. Above each group shall 34 be placed the name of the political party by which the can-35 didates comprising such group were placed in nomination, 36 or by the political designation as described in the certificate 37 of nomination, or nomination papers under the square. If 38 only one person be nominated by any party, or under any 39 political designation, his name with the office for which he 40 is a candidate shall be printed by itself under the name of 41 such party or political designation. A column marked 42 "Blank Column," with the same list of officers as is con-43 tained in the party columns or groups, shall be placed last 44 on said ballot, and under each office designated shall be left 45 sufficient blank space in which the voter can write the name 46 of such person as he may wish to vote for, if such name is 47 not printed on the ballot; and to the left of each party 48 column or group, in addition to the square at the head of 49 said column or group, shall be placed squares for a cross 50 (x), so that opposite each name and office on the ballot there 51 may be a square in which may be placed, by the voter so 52 desiring, the cross (x) as hereinafter provided. Whenever 53 the approval of a constitutional amendment or other ques-54 tion is submitted to the vote of the people such question or 55 questions shall be printed upon a separate ballot. The bal-56 lots shall be so printed as to leave a blank space, above such 57 amendment or question so as to give each voter a clear 58 opportunity to designate by a cross mark (x) therein, his 59 answers to the questions submitted and on the ballot may be 60 printed such words as will aid the voter to do this as "yes;" 61 "no," and the like. The ballot shall be not less than four 62 inches in width and not less than six inches in length. Before 63 distribution the ballots shall be so folded in marked creases 64 that their width and length when folded shall be uniform. 65 On the back and outside, when folded, shall be printed "Offi-66 cial ballot for," followed by the designation of the polling 67 place for which the ballot is prepared, the date of the elec-68 tion and a facsimile of the signature of the secretary of 69 state or city clerk who has caused the ballot to be printed. 70 Except as otherwise herein provided, ballots shall be printed 71 upon clean white paper without any distinguishing mark or 63 figures thereon."

Sect. 2. Section twenty-four of chapter six of the Revised 2 Statutes is hereby amended by striking out the following 3 words: "And if the voter shall desire to vote for any person 4 or persons, whose name or names are not printed as can-5 didates on the party group or ticket, he may erase any name 6 or names which are printed on the group or party ticket, 7 and under the name or names so erased he may fill in the 8 name or names of the candidates of his choice. Or if the 9 voter places and sticks on and over the name or names of 10 any candidate or candidates for any office or offices, a small 11 strip or strips of paper, commonly known as a sticker or 12 stickers, bearing thereon a name or names other than the

14 covered up, the name or names of such candidate or candi15 dates so covered shall be considered to be erased from the
16 ballot, and the person or persons whose name or names shall
17 so appear on such strip or strips of paper so placed and stuck
18 on the ballot, shall be deemed to be voted for by the voter as
19 candidate or candidates for such office or offices," and substi20 tuting instead thereof the following:— 'And if the voter
21 shall desire to vote for any person or persons, whose name
22 or names are not printed as candidates on the party group
23 or ticket, such voter shall make a cross (x) in the square
24 or squares at the left and before the name or names of such
25 person or persons, in another party group or ticket, for
26 whom he wishes to vote.

'If a group or ticket does not contain the names of candi-28 dates for all offices for which the voter shall desire to vote 29 he shall, in addition to the cross (x) in the square above the 20 name of the party group or ticket for which he wishes to 31 vote, vote for candidates for such offices so omitted by 32 making a cross (x) at the left and before the names of the 33 candidates for such offices in another party group or ticket, 24 or by writing the name of the person for whom he wishes 35 to vote, if not printed upon the ballot, in the "blank column," 36 referred to in section ten, under the title of the office,' so 37 that said section as amended shall read as follows:—

'Section 24. On receipt of his ballot the voter shall forth-39 with, and without leaving the inclosed space, retire alone to 20 one of the voting shelves or compartments so provided, and 41 shall prepare his ballot by marking in the appropriate mar-42 gin or place, a cross (x) as follows: He may place such 43 mark within the square above the name of the party group 44 or ticket, in which case he shall be deemed to have voted 45 for all the persons named in the group under such party or 46 designation. And if the voter shall desire to vote for any 47 person or persons, whose name or names are not printed as 48 candidates on the party group or ticket, such voter shall 49 make a cross (x) in the square or squares at the left and 50 before the name or names of such person or persons, in 51 another party group or ticket, for whom he wishes to vote.

'If a group or ticket does not contain the names of candi-53 dates for all offices for which the voter shall desire to vote, 54 he shall, in addition to the cross (x) in the square above the 55 name of the party group or ticket for which he wishes to 56 vote, vote for candidates for such offices so omitted by mak-57 ing the cross (x) at the left and before the names of the 58 candidates for such offices in another party group or ticket, 59 or by writing the name of the person for whom he wishes 60 to vote, if not printed upon the ballot, in the "blank column," 61 referred to in section ten, under the title of the office. Or 62 if the voter does not desire to vote for a person or persons 63 whose name or names are printed upon the party group or 64 ticket, he may erase such name or names with the effect that 65 the ballot shall not be counted for the candidate or candi-66 dates whose names are so erased. In case of a question 67 submitted to the vote of the people he shall place such mark

68 in the appropriate margin above the answer which he desires 69 to give. Before leaving the voting shelf or compartment, 70 the voter shall fold his ballot without displaying the marks 71 thereon, in the same way it was folded when received by 72 him, and he shall keep the same so folded until he has voted. 73 He shall vote in the manner provided by law before leaving 74 the enclosed space, and shall deposit his ballot in the box 75 with the official endorsement uppermost. He shall mark 76 and deposit his ballot without undue delay and shall quit 77 said inclosed space as soon as he has voted. No such voter 78 shall be allowed to occupy a voting shelf or compartment 79 already occupied by another, or to remain within said in-80 closed space more than ten minutes, or to occupy a voting 81 shelf or compartment for more than five minutes in case all 82 of such shelves or compartments are in use, and other voters 83 are waiting to occupy the same. No voter not an election 84 officer or an election clerk, whose name has been checked on 85 the list of the ballot clerks, shall be allowed to re-enter said 86 enclosed space, during said election. The presiding election 87 officer or officers, for the time being, shall secure the observ-88 ance of the provisions of this section.'

Sect. 3. All acts and parts of acts contrary to and incon-2 sistent herewith are hereby repealed.
