STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to amend sections five and six of chapter fifteen of the Public Laws of nineteen hundred and seven, as amended by chapter thirty-four of the Public Laws of nineteen hundred and nine and chapters eighty-four and one hundred seventy-six of the Public Laws of nineteen hundred and eleven, relating to the protection of trees and shrubs from dangerous insects and diseases.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section five of chapter fifteen of the Public 2 Laws of nineteen hundred and seven is hereby amended by 3 adding to said section, at the end thereof, the following:

'And said transportation companies shall immediately upon

5 receiving consignments notify the Commissioner of Agri6 culture of the fact that such consignments are in their pos7 session, or en route to some point within the state, and give
8 the names and addresses of the consignor and consignee,
9 destination of each shipment, the name of the transportation
10 company bringing such stock, and the road or roads over
11 which it is brought; and shall also make such further report
12 relative to such shipments as the Commissioner of Agricul13 ture may from time to time require.

Sect. 2. Section six of chapter fifteen of the Public Laws 2 of nineteen hundred and seven as amended by chapter thir-3 ty-four of the Public Laws of nineteen hundred and nine 4 and chapters eighty-four and one hundred and seventy-six 5 of the Public Laws of nineteen hundred and eleven is here-6 by amended by striking out all of said section except the 7 last paragraph, and substituting in place thereof the follow-8 ing: 'No person, firm or corporation, excepting growers, 9 shall engage in, continue in, or carry on the business of sell-10 ing or dealing in nursery stock, or solicit purchases of nurs-II ery stock within this state, either as owner thereof, or as 12 agent of such owner, without first obtaining a license to car-13 ry on and conduct such business in this state. The form of 14 license shall be prescribed by the State Horticulturist, and 15 the license shall be issued by him upon proper application 16 therefor, and shall run one year from date of issue. The 17 license fee shall be five dollars (\$5.00) per annum for agents, 18 dealers, salesmen or solicitors. The license shall be issued 19 in the name of the dealer, solicitor, salesman, or agent, as 20 the case may be, and no license shall be assigned or trans-Licenses of salesmen, dealers, agents, or solicitors 22 shall show the name and location of nursery and place of 23 business of the nurserymen or tree dealers whom they rep-24 resent or from whom they purchase their stock. Fees ob-25 tained from such licenses shall be paid into the State Treas-26 ury and added to the appropriation of the Bureau of Horti-27 culture, and shall be used exclusively for the inspection of 28 nursery stock introduced into the State of Maine from out-29 side the State of Maine. Such license may be revoked at 30 any time for failure to comply with aforesaid requirements, 31 or for such other causes as may in the opinion of the Com-32 missioner of Agriculture be deemed sufficient. Any viola-33 tion of these requirements shall be punishable by a fine of 34 not less than ten nor more than fifty dollars for each of-35 fense;' so that said section as amended shall read as follows:

'No person, firm or corporation, excepting growers, shall are engage in, continue in, or carry on the business of selling or 38 dealing in nursery stock, or solicit purchases of nursery stock within this state, either as owner thereof, or as agent of such 40 owner, without first obtaining a license to carry on and conduct such business in this state. The form of license shall 42 be prescribed by the State Horticulturist, and the license 43 shall be issued by him upon proper application therefor, and 44 shall run one year from date of issue. The license fee shall

45 be five dollars (\$5.00) per annum for agents, dealers, sales-46 men or solicitors. The license shall be issued in the name 47 of the dealer, solicitor, salesman, or agent, as the case may 48 be, and no license shall be assigned or transferred. Li-49 censes of salesmen, dealers, agents, or solicitors shall show 50 the name and location of nursery and place of business of 51 the nurserymen or tree dealers whom they represent or from 52 whom they purchase their stock. Fees obtained from such 53 licenses shall be paid into the State Treasury and added to 54 the appropriation of the Bureau of Horticulture, and shall 55 be used exclusively for the inspection of nursery stock in-56 troduced into the State of Maine from outside the State of 57 Maine. Such license may be revoked at any time for failure 58 to comply with aforesaid requirements, or for such other 50 causes as may in the opinion of the Commissioner of Agri-60 culture be deemed sufficient. Any violation of these re-61 quirements shall be punishable by a fine of not less than ten nor more than fifty dollars for each offense.

For the purpose of this act the term nursery stock is here-64 by applied to fruit trees, ornamental trees, shrubs and vines, 65 and includes current, gooseberry, blackberry and raspberry 66 bushes.'
