#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to authorize County Commissioners of Oxford County and the Municipal Officers of the Town of Rumford to provide a building at Rumford for County Court and Municipal Purposes.

## Be it enacted by the People of the State of Maine, as follows:

Section 1. The County Commissioners of the County of 2 Oxford and the municipal officers of the town of Rumford 3 in said county are hereby authorized and as soon as may 4 be hereafter, shall proceed jointly to acquire a suitable lot 5 of land in said town of Rumford and to construct and 6 maintain thereon a building suited to the needs of the 7 County of Oxford for court purposes and to the town of

- 8 Rumford for municipal purposes.
- Sect. 2. The cost and expense of land and construction of 2 buildings shall be borne equally by the County of Oxford 3 and the town of Rumford, and the cost and expense of the 4 maintenance, repair and general upkeep shall be borne in 5 equal shares by the County of Oxford and the town of 6 Rumford.
- Sect. 3. In order to provide funds for the county's share 2 in the purchase of land and the construction of such build-3 ing, the County Commissioners are hereby authorized to 4 raise by the issuance of interest bearing county bonds or 5 otherwise, a sum of money not to exceed twenty-five thou-6 sand dollars.
- Sect. 4. In order to provide funds for the town of Rum2 ford's share in the purchase of land and construction of
  3 building, the town of Rumford is hereby authorized to raise
  4 by the issuance of interest bearing town bonds, or other5 wise as the town may vote not to exceed twenty-five thou6 sand dollars.
- Sect. 5. This act shall not take effect until it has been 2 approved by the majority vote of the legally qualified voters 3 present and voting at a town meeting at which this matter 4 is properly before the meeting for action and a provision 5 has been made by said town for the raising of the town's 6 share of money required for the purchase of land and con-7 struction of building not to exceed the sum of twenty-five 8 thousand dollars
