IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to amend Chapter seventy-nine of the Revised Statutes, as amended by Chapter twenty-eight and one hundred seventy-five of the Public Laws of nineteen hundred and seven, as amended by Chapter forty-nine of the Public Laws of nineteen hundred and eleven, relating to the terms of the Supreme Judicial Court in Aroostook County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Chapter seventy-nine of the Revised Statutes,

- 2 as amended by chapter twenty-eight and one hundred sev-
- 3 enty-five of the Public Laws of nineteen hundred and seven,
- 4 as amended by chapter forty-nine of the Public Laws of

5 nineteen hundred and eleven, is hereby amended by striking 6 out words, "third Tuesday in September," in the ninth and 7 tenth line, and inserting in place thereof the words, 'fourth 8 Tuesday of August,' so that said section as amended shall 9 read as follows:

'Aroostook at Houlton on the first Tuesday of April, and 11 the third Tuesday of November, for civil and criminal busi-12 ness, and at Caribou on the first Tuesday of February and 13 the fourth Tuesday of August for civil business only. All 14 civil suits and processes which by law should have been 15 entered at the term of the said supreme court next after this 16 act takes effect, shall be returnable to, and be entered on 17 the docket of the said supreme judicial court at the August 18 term of same holden next after this act takes effect, and 19 shall have day in said supreme judicial court, and be heard 20 and disposed of as if originally entered therein, and all in-21 dictments and informations, and all parties, grand juries, 22 witnesses and others who have been held to appear at the 23 term of said supreme court which but for the passage of 24 this act would have been held in Houlton in September, 25 nineteen hundred and eleven shall be holden to appear at 26 the term of said supreme judicial court to be held 27 at Houlton in said county, in November next after this 28 act takes effect.'

Sect. 2. Said chapter twenty-eight and one hundred sev-2 enty-five of the Public Laws of nineteen hundred and seven, 3 and said chapter forty-nine of the Public Laws of nine hun-4 dred and eleven, and all other acts, or parts of acts, incon-5 sistent herewith, are hereby repealed.
