## STATE OF MAINE

### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to enlarge the powers and jurisdiction of the Western Somerset Municipal Court.

Be it enacted by the People of the State of Maine, as follows:
Section I. Section four of chapter three hundred and
2 thirty-one of the Private Laws of Maine of 1909 is hereby
3 amended by striking out the word "or" in the third line
4 thereof and by adding after the word "Bingham" the words
5 'or North Anson,' so that said section as amended shall
6 read:

'Sect. 4. Said court shall be in constant session for the 8 trial of criminal cases, and criminal session thereof may 9 be held at Skowhegan, Fairfield, Madison, Bingham, or 10 North Anson, the place of hearing in all cases to be deter-11 mined by the judge, having regard to the convenience of 12 the parties and counsel, and the expense to the county.'

Sect. 2. Section five of said chapter three hundred and 2 thirty-one is hereby amended by adding after the word 3 forenoon in the eleventh line thereof the words 'at North 4 Anson on the third Monday of January, March, May, July, 5 September and November at eleven o'clock in the forenoon,' 6 so that said section as amended shall read:

'Sect. 5. Regular terms of said court for the transaction 8 of civil business shall be held as follows:

At Skowhegan on the first Monday of every month ex-10 cepting August, at ten o'clock in the forenoon.

At Fairfield on the second Monday of January, March, 12 May, July, September and November, at nine o'clock in the 13 forenoon.

At Madison on the last Monday of every month excepting 15 July, at nine thirty o'clock in the forenoon.

At Bingham on the second Monday of February, April, 17 June, October and December, at eleven o'clock in the fore-18 noon.

At North Anson on the third Monday of January, March, 20 May, July, September and November, at eleven o'clock in 21 the forenoon.

Sect. 3. Section six of chapter three hundred and thirty-2 one is hereby amended by striking out the word "and" in 3 the second line thereof and adding after the word "Bing4 ham" the words 'and Anson,' so that said section as 5 amended shall read:

'Sect. 6. The municipal officers of the towns of Skowhe-7 gan, Fairfield, Madison, Bingham, and Anson shall provide 8 suitable rooms and facilities for the holding of the sessions 9 of said court, and all processes shall be returnable accord-10 ingly.'
