STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT relating to the Committing of Burglary with Explosives.

Be it enacted by the People of the State of Maine, as follows:

Section 1. That any person who, with intent to commit

- 2 burglary, breaks and enters in the night time any building
- 3 in which there is a human being, and commits a burglary by
- 4 the use of nitro-glycerine, dynamite, gun-powder or any
- 5 other explosive, shall be deemed guilty of burglary with ex-
- 6 plosives, and any person convicted of such offence shall be
- 7 punished by imprisonment in the state prison at hard labor
- 8 for a period of not less than twenty years and not more than
- 9 thirty years.

Sect. 2. That any person who, with intent to commit burg2 lary, breaks and enters in the day time any building in which
3 there is a human being, and commits a burglary by the use of
4 nitro-glycerine, dynamite, gun-powder or any other explo5 sive, shall be deemed guilty of burglary with explosives, and
6 any person convicted of such offense shall be punished by
7 imprisonment in the state prison at hard labor for a period
8 of not less than fifteen years and not more than thirty years.

Sect. 3. That any person who, with intent to commit burg2 lary, breaks and enters in the night time any building in
3 which there is no human being, and commits a burglary by
4 the use of nitro-glycerine, dynamite, gun-powder or any
5 other explosive, shall be deemed guilty of burglary with ex6 plosives, and any person convicted of such offense, shall be
7 punished by imprisonment in the state prison at hard labor
8 for a period of not less than ten years and not more than
9 thirty years.

Sect. 4. That any person who, with intent to commit burg2 lary, breaks and enters in the day time any building in which
3 there is no human being, and commits a burglary by the use
4 of nitro-glycerine, dynamite, gunpowder or any other ex5 plosive, shall be deemed guilty of burglary with explosives,
6 and any person convicted of such offense shall be punished
7 by imprisonment in the state prison at hard labor for a pe8 riod of not less than five years and not more than thirty
9 years.

Sect. 5. All acts and parts of acts inconsistent with the 2 provisions of this act are hereby repealed.
