STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to amend section fifty-one of chapter fifteen of the Revised Statutes, as amended, relating to the election of truant officers.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section fifty-one of chapter fifteen of the Re-

- 4 ter two hundred thirty-eight of the Public Laws of nineteen
- 5 hundred nine, as amended by chapter one hundred thirteen
- 6 of the Public Laws of nineteen hundred eleven, is hereby
- 7 further amended by striking out the words "cities and
- 8 towns" in the first line and inserting in place thereof the

9 words 'the superintending school committee of every city 10 and town' and by striking out the word "the" in the fifth II line and inserting in place thereof the word 'said' and by 12 striking out the words "city or town" in the ninth line and 13 inserting in place thereof the word 'state' and by inserting 14 after the word "report" in the twenty-third line the words 15 'in writing' and by inserting after the word "report" in the 16 twenty-sixth line the words 'in writing' and by striking out 17 all of said section after the word "statutes" in the thirty-18 fourth line thereof and substituting in place thereof the fol-'Superintending school committees shall elect 10 lowing: 20 truant officers at their first meeting after the annual meet-21 ing of the town; they shall fill any vacancies occurring dur-22 ing the year and they shall have authority to fix the com-23 pensation of said officers and said compensation shall be 24 paid from the appropriation made for salaries of municipal 25 officers. Any truant officer neglecting any duty required of 26 him under the provisions of this chapter shall be liable to 27 a fine of not less than ten nor more than fifty dollars and 28 any town failing through its superintending school com-20 mittee to meet said provisions shall be liable to the provi-30 sions of section sixteen of this chapter' so that said section 31 when amended shall read as follows:

'Sect. 51. The superintending school committee of every 33 city and town shall annually elect one or more persons, to 34 be designated truant officers, who shall inquire into all cases 35 of neglect of the duties prescribed in section forty-nine and

36 ascertain the reasons therefor and shall promptly report 37 the same to said superintending school committee, and such 38 truant officers or any of them shall, when so directed by the 30 school committee or superintendent in writing, prosecute 40 in the name of the state any person neglecting to perform 41 the duties prescribed in said section, by promptly entering 42 a complaint before a magistrate; and said officer shall, 43 when notified by any teacher that any pupil is irregular in 44 attendance, arrest and take such pupil to school when found 45 truant; and further such officers shall enforce the provi-46 sions of sections one hundred eighteen to one hundred 47 twenty, inclusive, of this chapter. Truant officers, when 48 so directed in writing by the superintendent of schools or 49 the superintending school committee of their respective 50 towns may visit the manufacturing, mechanical, mercantile 51 and other business establishments in their several cities and 52 towns during the hours in which the public schools of such 53 city or town are in session, and ascertain whether any 54 minors under the age of fifteen years are employed therein, 55 and shall report in writing any cases of such employment 56 to the superintendent of schools or the superintending 57 school committee of their city or towns and if employed 58 therein contrary to the provisions of chapter forty, shall 59 also report in writing such illegal employment to the com-60 missioner of labor. The owner, superintendent, overseer 61 or agent of all manufacturing, mechanical, mercantile or 62 other business establishments, upon request, shall produce

63 for the inspection of such truant officers all certified copies 64 of records of birth and baptism, passports and age and 65 schooling certificates required to be kept on file in such 66 establishments under chapter forty of the Revised Statutes. 67 Superintending school committees shall elect truant officers 68 at their first meeting after the annual meeting of the town; 69 they shall fill any vacancies occurring during the year and 70 they shall have authority to fix the compensation of said 71 officers and said compensation shall be paid from the ap-72 propriation made for the salaries of municipal officers. 73 Any truant officer neglecting any duty required of him 74 under the provisions of this chapter shall be liable to a fine 75 of not less than ten nor more than fifty dollars and any 76 town failing through its superintending school committee 77 to meet said provisions shall be liable to the provisions of 78 section sixteen of this chapter.'
