STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTEEN.

AN ACT to amend Chapter 117 of the Public Laws of 1905 relating to compensation of county commissioners.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section 1 of chapter 117 of the Public Laws

- 2 of 1905 is hereby amended by adding to said section the
- 3 following words: 'and excepting also such expenses as are
- 4 provided in section 2 of this act,' so that said section as
- 5 amended shall read as follows:

'Section 1. The annual salary for each county commis-

- 7 sioner for the several counties, shall be as follows:
- 8 Androscoggin, six hundred dollars.

- 9 Aroostook, eleven hundred dollars.
- 10 Cumberland, one thousand fifty dollars.
- 14 Franklin, three hundred and fifty dollars.
- 12 Hancock, seven hundred and fifty dollars.
- 13 Kennebec, one thousand dollars.
- 14 Knox, three hundred dollars.
- 15 Lincoln, three hundred dollars.
- 16 Oxford, five hundred dollars.
- 17 Penobscot, twelve hundred dollars.
- 18 Piscataquis, five hundred dollars.
- 19 Sagadahoc, two hundred and fifty dollars.
- 20 Somerset, six hundred and fifty dollars.
- 21 Waldo, four hundred dollars.
- 22 Washington, five hundred and fifty dollars.
- 23 York, seven hundred and fifty dollars.
- Said salaries are payable from the county treasuries in
- 25 quarterly payments on the first days of January, April, July
- 26 and October of each year, in full for all services, expenses
- 27 and travel, including the management of the jail workshops
- 28 and the sale of their products, except actual necessary cash
- 29 expenses incurred outside of their respective counties for
- 30 the transaction of official business; all bills for such expenses
- 31 shall be approved by the clerk of courts and the county at-
- 32 torney of their county, and excepting also such expensees as
- 33 are provided in section 2 of this act.'
 - Sect. 2. Section 2 of said chapter 117 is hereby amended
 - 2 by adding to said section the following words: 'The county

- 3 treasurer shall pay to said commissioners actual travelling
- 4 expenses aforesaid when collected by the county attorney,'
- 5 so that said section as amended shall read as follows:
- 'Sect. 2. For services performed by county commissioners 7 in the assessment of damages for land or easements sought 8 to be taken or acquired by private corporations, they shall 9 charge three dollars a day and actual traveling expenses, 10 and certify the same in a bill of items to the county attorning, who shall collect the sums so charged of the party 12 seeking to exercise the right of eminent domain, and forthing with pay the same to the county treasurer. The county 14 treasurer shall pay to said commissioners actual travelling

15 expenses aforesaid when collected by the county attorney.'
