# STATE OF MAINE

### IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT amending Section twelve of Chapter seventeen of the Revised Statutes, as amended by Chapter thirty-one of the Public Laws of 1911, relating to the Registration of Physicians and Surgeons.

Be it enacted by the People of the State of Maine, as follows:
Section twelve of chapter seventeen of the revised statutes,
a samended by chapter thirty-one of the public laws of 1911,
is hereby further amended by striking out in the second
sentence the words, "of some reputable medical school or
college in good standing, having power to confer degrees in
medicine, and maintaining a standard of preliminary education and of medical instruction approved by the board,

8 which said standard shall at least require that the applicant 9 for admission to said medical school or college shall present 10 to said school or college, before beginning the study of medi-11 cine therein, the diploma," also by striking out in the fifth 12 sentence the words, "materia medica and therapeutics," "the 13 principles and practice of medicine" and "such branches of 14 medical science as the board may deem necessary for the 15 applicant to be versed in," and by inserting after the word 16 "chemistry" the words 'toxicology, dietetics, diagnosis,' also 17 after the word "surgery" the words 'gynecology and,' so that 18 said section as amended shall read as follows :

'Sect. 12. The board shall examine all applicants for reg-20 istration as licensed physicians or surgeons. Each appli-21 cant shall, at least seven days before the date of his exam-22 ination, present to the secretary of the board an application 23 under oath or affirmation, containing satisfactory proof that 24 said applicant is twenty-one years of age, of good moral 25 character and a graduate of a high school or equivalent 26 school having a course of study requiring an attendance 27 through four years, or a certificate of having passed a sat-28 isfactory examination before the state superintendent of 20 schools, or like state officer, in the studies embraced in the 30 curriculum of such high school or other equivalent school. 31 He shall also present such other facts as the board in its 32 blank application may require, and must pay the fees pro-33 vided in the preceding section. Examinations shall be in 34 whole or in part in writing and shall be of a thorough and 35 practical character. They shall embrace the general sub-36 jects of anatomy, physiology, pathology, bacteriology, sani-37 tation, chemistry, toxicology, dietetics, diagnosis, surgery, 38 gynecology and obstetrics. The board may make such rules 39 and regulations as may be necessary for reciprocity or 40 licensure with the boards of other states which maintain a 41 standard of education at least equal to their own; but no 42 such rules shall become operative until they have been ap-43 proved by a justice of the supreme judicial court.'
