STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIFTEEN

AN ACT to amend Chapter thirty-one of the Private and Special Laws of nineteen hundred and five, entitled "An Act to authorize the Houlton Water Company to generate, sell and distribute electricity," as amended by Chapter one hundred and six of the Private and Special Laws of nineteen hundred and seven.

Be it enacted by the People of the State of Maine, as follows:

Section four of chapter thirty-one of the private and special laws of nineteen hundred and five, as amended by chapter one hundred and six of the private and special laws of nineteen hundred and seven is hereby further amended by adding in line three after the word "aforesaid" thereof the

6 words 'and for the purposes specified and stated in chapter
7 three hundred and forty-eight of the private and special
8 laws of nineteen hundred and nine and for the purpose of
9 purchasing the plant and business of any person, partnership
10 or corporation carrying on or doing any electric business in
11 the town of Houlton,' and by striking out the word "forty"
12 in line four of said section four and inserting in lieu thereof
13 the words 'one hundred and twenty,' and by striking out
14 the word "forty" in the sixth and seventh lines thereof and
15 inserting in lieu thereof the words 'one hundred', so that
16 said section four, as amended, shall read as follows:

'Sect. 4. Said company or corporation may lease, purchase,
18 acquire and hold real and personal estate, necessary and
19 convenient for the purposes aforesaid and for the purposes
20 specified and stated in chapter three hundred and forty-
21 eight of the private and special laws of nineteen hundred
22 and nine, and for the purpose of purchasing the plant and
23 business of any person, partnership or corporation carrying
24 on or doing any electric business in the Town of Houlton,
25 to an amount not exceeding one hundred and twenty thou-
26 sand dollars; may sell and convey the same; and may issue,
27 negotiate and sell its bonds to an amount not exceeding one
28 hundred thousand dollars for the purposes stated in this
29 act, and said bonds to the amount of one hundred thousand
30 dollars may be purchased and held by the savings banks and
31 trust companies of Maine.'
