## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to divide the Town of Cumberland.

Be it enacted by the People of the State of Maine, as follows:
Section 1. All that part of the Town of Cumberland
2 known as Chebeague Island, Hope Island, Basket Island,
3 Clapboard Island, Bangs' Island, Goose Nest Island, Sturdi4 vant's Island, Sand Island, Stave Island, Ministerial Island,
5 Bates' Island, Brown Cow Island, and all other islands, or
6 parts of islands, belonging to said Town of Cumberland, is
7 hereby incorporated into a separate Town by the name of
8 Chebeague, and the Inhabitants thereof are hereby vested
9 with all the powers and privileges, and subject to the duties
10 and liabilities incident to other Towns in this State.

The several Inhabitants of said Town of Chebeague shall 1.2 be holden to pay the taxes which have been legally assessed 1.3 upon them by the Town of Cumberland. The several Col-1.4 lectors of Taxes for said Town of Cumberland are hereby 1.5 authorized and required to collect and pay all taxes to them. 16 already committed according to their respective warrants.

All moneys now in the Treasury of said Town and all sums 18 which shall hereafter be received from taxes heretofore as-19 sessed shall be applied to the several purposes for which 20 they were raised.

Said Town of Chebeague shall be holden to pay the said 22 Town of Cumberland its due proportion of all debts and 23 liabilities of said Town, now existing upon contract, or 24 otherwise, or which may hereafter arise in consequence of 25 any suits pending against said Town, or which may here-26 after be commenced on any cause of action which may now 27 exist against said Town, the same to be paid to the Town 28 of Cumberland when said liabilities accrue. The said pro-29 portion to be estimated upon the valuation of the property 30 as made by the Assessors for the year nineteen hundred and 31 fourteen.

The Inhabitants of said Town shall continue to hold and 33 enjoy in common the rights and privileges hitherto belong-34 ing to the inhabitants of Cumberland in any and all public 35 landings, cemeterics, mussel beds, flats, gravel beds, and 36 fisheries of every kind within the limits of Casco Bay.

The several school houses located upon said Chebeague

38 Island shall be and become the property of said Town of 39 Chebeague.

All persons hereafter becoming chargeable as paupers 41 shall be chargeable to that Town on whose territory they 42 last resided.

The Town of Cumberland shall at its Annual Meeting, or 44 at a special meeting to be held hereafter, elect, by ballot, two 45 Commissioners, and the Town of Chebeague shall at its first 46 meeting, or at a special meeting to be held hereafter, elect, 47 by ballot, two Commissioners, and the four Commissioners 48 so elected shall constitute a Board of Commissioners who 40 shall, as soon as may be practicable, appraise all of the real 50 and personal property which shall belong to the Town of 51 Cumberland at the time of the approval of this Act; and 52 after hearing the parties shall determine what part of said 53 real and personal property shall belong to said Town of 54 Chebeague, and what part shall belong to said Town of 55 Cumberland; and shall determine and award the sum of 56 money which shall be paid in gross or annually by either of 57 said Towns to the other for such real or personal property, 58 to equitably adjust the rights of each Town upon said 59 division.

And said Commissioners shall further ascertain all the lia-61 bilities of said Town of Cumberland and shall determine 62 what proportion of said indebtedness shall be paid by the 63 Town of Cumberland and what proportion shall be assumed 64 and paid by said Town of Chebeague.

And said Commissioners shall hear the parties and make 66 adjustment of the rights and liabilities of said Towns in re-67 lation to the enjoyment of the rights and privileges of said 68 Towns in the Greeley Institute, now located within said 69 Town of Cumberland, according to the provisions of the 70 will of Eliphalet Greeley.

And said Commissioners may make an award in all said 72 matters and said award shall be final, and shall convey the 73 property so awarded to each of said Towns; and all sums of 74 money so awarded shall be paid within six months from the 75 date of said award, unless otherwise determined by said 76 Commissioners. In case said Commissioners shall not unan-77 imously agree upon an award in any of the matters herein 78 submitted to them they shall submit the matter of disagree-79 ment to the County Commissioners of Cumberland County. 80 who shall examine the matter in relation to which the dis-81 agreement arises, after notice to and hearing of both par-82 ties, and shall make their award and return it to the Town 83 Clerks of said Towns, to be recorded in like manner and 84 with like effect as an award of the Commissioners.

In case either Town shall neglect or refuse to choose said 86 Commissioners at the time, or in the manner provided by 87 this Act, or in case any of said Commissioners shall refuse 88 to act, or there shall be a vacancy by death, or otherwise, in 89 either case said County Commissioners shall fill the vacancy 90 by the appointment of some proper person, or persons, re-91 siding in the Town where the vacancy shall occur.

Any justice of the peace may call the first meeting of the 93 Town of Chebeague by posting a warrant therefor, stating 94 the purposes of the meeting, in three public and conspicuous 95 places in said Town, at least seven days before the time of 96 holding said meeting.
