STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT Relating to the Removal of Brown-tail Moth Nests within the Limits of the Highway.

Be it enacted by the People of the State of Maine, as follows:

Section 7 of chapter 15 of the public laws of 1907 as 2 amended by chapter 34 of the public laws of 1909 and chap-3 ter 84 of the public laws of 1911, is hereby further amend-4 ed by striking out the fourth sentence and substituting in 5 place thereof the following:

Said limit to extend to and include all trees whose 7 branches overhang the highway;' so that said section as 8 amended shall read as follows:

HOUSE-No. 227.

'Should any person in the state suspect the presence of 10 the brown-tail moth or Sau Jose scale preying upon trees, 11 shrubs or vines in his possession or within his knowl-12 edge he shall forthwith notify the commissioner of ag-13 riculture to that effect; and it shall be the duty of said com-14 missioner to cause the said trees, shrubs or vines to be in-15 spected. If sufficient cause be found the commissioner of 16 agriculture shall forthwith notify the municipal officers of 17 the city or town where such pests have been found. Mu-18 nicipal officers thus notified shall immediately cause to be 10 destroyed such of the above named insects in their different 20 stages as may be found within the limits of the public streets 21 and parks. Said limit to extend to and include all trees 22 whose branches overhang the highway. Should such mu-23 nicipal officers neglect or fail within a reasonable time to 24 perform the duties herein imposed upon them, then the 25 commissioner of agriculture shall order such city, town or 26 plantation to proceed to destroy the above named insects 27 in accordance with methods to be prescribed by him and 28 to spend such an amount in the above named work as he 20 shall deem necessary.

If any city, town or plantation shall fail to comply with 31 the directions of said commissioner in the performance of 32 said work and the expenditure of such money within the 33 time specified by him, then the commissioner of agriculture 34 shall cause the said work to be done and shall charge the 35 actual expense of the same to said city or town; such 36 amount to be collected as a state tax and credited to this 37 appropriation.

Whenever a city, town or plantation is notified by the com-39 missioner of agriculture of the presence of the brown-tail 40 moth or San Jose scale, the mayor of each city, the select-41 men of each town and the assessors of each plantation shall 42 notify each owner of real estate located therein, requiring 43 him to destroy the above named insects in his orchard and 44 shade trees within a specified time. If the owner fails to 45 destroy the above named insects before the specified time, 46 then the city, town or plantation subject to the approval 47 of the commissioner of agriculture, shall destroy them, and 48 shall assess upon such aforesaid real estate the actual cost 49 of so doing, to an amount, however, not exceeding one per 50 cent of the assessed valuation of the above named property. 51 The amount so assessed shall be collected in the form of a 52 tax.

It shall be the duty of the Commissioner of agriculture to 54 disseminate information concerning the brown-tail and gypsy 55 moths. San Jose scale, and other injurious insects.

Cities and towns may raise the sums necessary to carry out 57 the provisions of this section in the same manner in which 58 money is raised for other necessary municipal purposes.'
