STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend section thirty-nine of chapter forty-one of the Revised Statutes relating to taking Alewives, by West Harbor Ice Company.

Presented by Mr. Maxwell of Boothbay Harbor.

Section thirty-nine of chapter forty-one of the revised stat-2 utes is hereby amended by inserting after the word "stream" 3 at the end of the eighteenth line the following: 'nor shall it 4 apply to the taking of alewives by the West Harbor Ice 5 Company in the waters below its fishway, erected under 6 authority given by chapter one hundred and forty of the 7 private and special laws of nineteen hundred and five,' so 8 that said section as amended shall read as follows:

'Sect. 39. No salmon, shad or other migratory fish shall 10 be taken or fished for within five hundred yards of any 11 fishway, dam or mill race; nor in the Penobscot river be-12 tween the mouth of the Kenduskeag stream and the water 13 works dam at Treat's falls on said river, nor between the 14 Augusta highway bridge over the Kennebec river and the 15 Augusta dam; nor in mill river, a tributary of Georges river 16 in Thomaston, Maine, between the Georges river and the 17 old dam at head of tide waters in said Mill river; nor any 18 salmon five hundred feet above Ferry Point bridge on the 19 St. Croix river in Calais, between the first days of April 20 and November except by the ordinary mode of angling with 21 single hook and line or artificial flies; nor shall hook and 22 line and artificial flies be used at any time within one hun-23 dred yards of any fishway, dam or mill race, but this sec-24 tion shall not apply to the taking of alewives by the town 25 of Warren in the George river, and by the town of Waldo-26 boro in Medomak river, under the authority granted said 27 towns by a private and special law of Massachusetts, passed 28 March six, eighteen hundred and two, and amendments 29 thereof, passed by the legislature of this state; nor shall 30 it apply to the taking of alewives by the town of Woolwich 31 in Nequasset stream, nor shall it apply to the taking of 32 alewives by the West Harbor Ice Company in the waters 33 below its fishway erected under authority given by chapter 34 one hundred and forty of the private and special laws of 35 nineteen hundred and five. Fly fishing shall be allowed up 36 to the bridge across Denny's river at Lincoln's mill, but not 37 between said bridge and Lincoln's mill dam. This section 38 shall not apply to the Laconia falls and Lower falls, so 39 called, of the Saco river, located at Biddeford and Saco; 40 and upon the first three days of each week, from the first 41 of June to the first of September of each year, all persons 42 may dip for salmon, shad and alewives at the falls last 43 named above. Any person may take salmon, shad or ale-44 wives in the waters of Orange river, in the town of Whit-45 ing, in the county of Washington, up to one hundred and 46 thirty yards of the fishway at the lower dam in said river, 47 subject, however, to all the laws of the state, and laws reg-48 ulating the taking of fish in said river. The penalty for 49 any violation of this section is a fine of not more than fifty, 50 nor less than ten dollars for each offence, and a further fine 51 of ten dollars for each salmon and one dollar for each shad 52 so taken.'
