AN ACT to authorize the Electric System Corporation of Ed-  
mundston, New Brunswick, to exercise certain powers in this  
state.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. Raymond Albert, F. W. Pellitier and Luc Al-  
bert and their associates, successors and assigns are hereby  
created a Corporation, by the name of the Madawaska Elec-  
trical Power Company, with all the powers and privileges of  
similar Corporations.

Sect. 2. Said Corporation is hereby authorized to pur-  
chase electricity for lighting, heating and power purposes  
from the Electric System Corporation of Edmunston, New

4 Brunswick, and to supply the same to the towns of Mada-  
5 waska, Frenchville and Saint Agatha, obtaining the written  
6 consent therefor from the selectmen of said towns of Mad-  
7 awaska, Frenchville and Saint Agatha, and said Corporation  
8 is authorized to erect and maintain a line or lines of posts  
9 and wires with all necessary stations and fixtures from its  
10 main lines through towns of Madawaska, Frenchville and  
11 St. Agatha. Nothing in this act shall require any Corpora-  
12 tion organized under the general laws of the state for the  
13 sale and distribution of electricity in said Madawaska,  
14 Frenchville or St. Agatha to obtain any special act of the  
15 legislature therefor. Said Corporation shall be subjected to  
16 all laws of the state of Maine regulating similar Corpora-  
17 tion in said state hereafter passed, applicable to Corporation  
18 in a similar business.

Sect. 3. All locations upon streets, roads or ways neces-  
2 sary for the purpose of this act are hereby granted and the  
3 Municipal Officers of all towns named herein shall designate  
4 the streets, roads or ways so to be occupied, the place where  
5 the poles shall be set and shall establish such reasonable re-  
6 strictions as to the kind of poles, their construction and  
7 maintenance, the height of wires and the use of guard wires,  
8 as they deem proper.
