# STATE OF MAINE

RESOLVE, Providing a State Pension for Hannah M. Condon.

Resolved, That there be paid Hannah M. Condon of Wins-2 low the sum of eight dollars per month, payable quarterly 3 from the fund appropriated for military pensions, to begin 4 January first, nineteen hundred fifteen.

## STATEMENT OF FACTS IN THE HANNAH M. CON-DON CASE.

William Condon was a private in Company G, 11th Mass. Vol. Infantry. Hannah M. Condon is the widow of said William Condon. Hannah M. Condon is 80 years old the 4th of February, 1015. She is sick, in bed most of the time, with cancer of the breast. Doctor's certificate accompanies this. She receives a U. S. pension of \$12.00 per month. It is absolutely necessary for her to be taken care of and a sister, aged 78 years old, cares for her. The latter has no income of her own. She has a niece who teaches school on Southport Island, who pays their house rent, in part of a farm house in Winslow. As William Condon served in a Massachusetts regiment and at present his widow is a resident of Maine and has been for fifteen or twenty years, "as per vouchers accompanying this," she cannot get a pension from Maine without a special act of the Maine Legislature and is not eligible to state aid from Massachusetts. Will produce her certificate, entitling her to a pension from the U. S., at the hearing of your committee.
