STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to Amend Sec. 3 of Chap. 41 of the Revised Statutes Relating to Sea and Shore Fisheries.

Be it enacted by the People of the State of Maine, as follows:

That Sec. 3 of Chapter 41 of the Revised Statutes, as 2 amended by Public Laws of 1905, Chapter 108, be amended 3 by striking from said section the words "and then only in 4 the day time," and the words later appearing in said section 5 "in the day time"; so that said section as amended shall read

- 5 "in the day time"; so that said section as amended shall read 6 as follows:
- 'Sec. 3. The fish wardens shall enforce all laws relating 8 to the sea and shore fisheries within the counties in which 9 they respectively reside, but they shall not exercise jurisdic-

10 tion in any other county unless so instructed in writing by
11 the commissioner of sea and shore fisheries.

The commissioner of sea and shore fisherise and fish war-13 dens may with or without a warrant arrest any person whom 14 they may have reasonable grounds to believe guilty of vio-15 lating any of the provisions of this chapter, and may with 16 or without a warrant enter upon, open and search any ves-17 sel, boat, building, car, trap or other receptacle or place 18 where they have reasonable grounds to believe that fish or 19 lobsters liable to seizure are to be found, and seize and carry 20 away all fish or lobsters liable to seizure found therein, and 21 any lobster car, trap, net, barrel, box or package in which 22 the same are found or which are liable to seizure under any 23 of the provisions of this chapter, the fish, lobsters, or other 24 property thus seized to be disposed of according to law; 25 but no dwelling house or hotel shall be searched without a 26 warrant issued for that purpose, and no lobster car marked 27 with the name of the owner as required by law shall be 28 opened or bailed by any officer without a warrant, until 29 notice of such intended search has been given to the owner 30 of such car or person having the same in charge or such 31 notice has been left at the residence or place of business of 32 such owner or person. Any magistrate may issue warrants 33 to search within his jurisdiction any dwelling house or 34 hotel, or any building, vessel, boat or receptacle for fish or 35 lobsters, or any place or places used therefor, to the com-36 missioner of sea and shore fisheries, or fish warden ap37 pointed and qualified as provided in this chapter. Such 38 warrants shall issue subject to the requirements of section 39 thirteen of chapter one hundred and thirty-three.'
