STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend Chapter 61 of the Laws of 1891, relating to Limerock Railroad Company.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section 1 of chapter 61 of the laws of 1891 is

- 2 hereby amended so as to read as follows: "Francis Cobb,
- 3 Timothy Williams, Maynard Sumner, Nathan A. Farwell,
- 4 William Wilson, Cornelius Hanrahan, John W. Hunt,
- 5 Charles W. Snow, Jonathan White, Benjamin Clark, John
- 6 T. Berry, George W. Ricker and Thomas Colson, their as-
- 7 sociates, successors and assigns, are hereby constituted a
- 8 corporation by the name of the Limerock Railroad Com-
- 9 pany, with authority to construct, maintain, operate or use,

10 one or more lines of railroad operated by steam, horse or 11 other power, with single or double tracks between the lime 12 quarries in the several towns in the County of Knox, in 13 such direction as may best convene the transportation ⋅ of 14 lime stone and other freight from said quarries to the va-15 rious kilns and to and from other places, with convenient 16 branches to accommodate each kiln and quarry. The loca-17 tions of its railroad, as heretofore made by said corporation, 18 are hereby declared to be legal and valid. Said corporation 19 is hereby authorized and empowered to construct, maintain, 20 use and operate all side tracks, spurs, turnouts and branches, 21 and to make such additions to its present location, from 22 time to time, as may be necessary or convenient in order to 23 reach the various lime quarries and lime kilns that are now 24 opened or built, or that may be hereafter opened or built, 25 in said county. Said corporation is hereby authorized to 26 construct, maintain and operate its railroad over and across 27 tide waters in Lermond's Cove, in said Rockland, so as to 28 connect its present termini. When constructed across said 29 cove, said road shall be constructed with all necessary draws, 30 maintained and operated at the expense of said corpo-31 ration, so that all kinds of navigation may be able to reach 32 all of the riparian property around said cove.

Sect. 2. Said corporation is hereby authorized to purchase, 2 or consolidate with the Rockport Railroad, and said Rock-3 port Railroad is authorized to make such sale or consolidation, the terms thereof to be such as said companies may

5 agree upon, and when made shall vest said Limerock Rail6 road with all the franchises, rights and powers, and subject
7 it to all the liabilities of said Rockport Railroad. Said
8 Limerock Railroad Company is authorized to make con9 tracts for the transportation of limerock and other freight
10 over any road with which it may be connected, and by con11 sent of such road to transport limerock and other freight
12 over the same.
