*To the People of the State of Maine in Legislature Assembled:*

The undersigned, Frank W. Burns and Harry P. Burns of Fort Fairfield in the county of Aroostook and State of Maine, respectfully represent that the premises conveyed to us by two certain deeds, to-wit, a deed to us from Austin M. Foss dated May 1, 1906, and recorded in the Aroostook Registry of Deeds in Vol. 221, Page 277, and a deed to us from Osman D. Bean dated May 5, 1906, and recorded in said Registry of Deeds in Vol. 221, Page 294, are located within the present limits of the Fort Fairfield Village Corporation; that said premises are so located as to receive no benefit from the fire protection and street sprinkling afforded to other property in said Fort Fairfield Village Corporation by the water system located therein; that said premises always have been, and are now, subject to

taxation in said village corporation for fire protection, street sprinkling and other purposes; that inasmuch as said property above described can receive no benefit from the taxes assessed thereon by the said Fort Fairfield Village Corporation, we therefore respectfully ask that the premises described in said deeds, and the poll of the said Harry P. Burns, be set off from the present limits of said Fort Fairfield Village Corporation, as provided in a draft of a bill for that purpose, hereto attached, and entitled An Act to Amend Section one of Chapter one hundred sixty-six of the Private and Special Laws of eighteen hundred eighty-seven, entitled "An Act Creating the Fort Fairfield Village Corporation," as amended by Chapter three hundred three of the Private and Special Laws of 1905, and as amended by chapters one hundred sixteen and two hundred ten of the private and special laws of 1907, as amended by chapter two hundred forty-two of the private and special laws of 1909, and as amended by chapter fifty of the private and special laws of 1913."

*To the People of the State of Maine in Legislature Assembled:*

The undersigned, Frank W. Burns of Fort Fairfield in the County of Aroostook and State of Maine, respectfully represent that the premises conveyed to me by Albert R. Wellman, A. Pearl Wellman and Lizzie S. Robbins by their deed dated March 29, 1909, and recorded in the Aroostook Registry of Deeds in Vol. 238, Page 382, are located within the present limits of the Fort Fairfield Village Corporation; that said premises are so located as to receive no benefit from the fire protection and street sprinkling afforded to other property in said Fort Fairfield Village Corporation by the water system located therein; that said premises always have been, and now are, subject to taxation in said Village Corporation for fire protection, street sprinkling and other purposes; that inasmuch as said property above described can receive no benefit from taxes assessed thereon by said Fort Fairfield Village Corporation, I respectfully ask that the premises described in said deed be set off from the present limits of said Fort Fairfield Village Corporation, as provided in a draft of a bill for that purpose, hereto attached, and entitled, An Act to Amend Section one of Chapter one hundred sixty-six of the Private and Special Laws of eighteen hundred eighty-seven, entitled "An Act Creating the Fort Fairfield Village Corporation," as amended by Chapter three hundred three of the Private and Special Laws of 1905, and as

amended by Chapters one hundred sixteen and two hundred ten of the Private and Special Laws of 1907, as amended by Chapter two hundred forty-two of the Private and Special Laws of 1909, and as amended by Chapter fifty of the Private and Special Laws of 1913.”

AN ACT to amend Section one of Chapter one hundred sixty-six of the Private and Special Laws of eighteen hundred eighty-seven, entitled "An Act Creating the Fort Fairfield Village Corporation," as amended by Chapter three hundred three of the Private and Special Laws of nineteen hundred five, and as amended by Chapters one hundred sixteen and two hundred ten of the Private and Special Laws of nineteen hundred seven, as amended by Chapter two hundred forty-two of the Private and Special Laws of nineteen hundred nine, and as amended by Chapter fifty of the Private and Special Laws of nineteen hundred thirteen.

*Be it enacted by the People of the State of Maine, as follows:*

Section one of chapter one hundred sixty-six of the private  
2 and special laws of eighteen hundred eighty-seven as amend-  
3 ed by chapter three hundred three of the private and spe-  
4 cial laws of nineteen hundred five, and as amended by chap-  
5 ter one hundred sixteen and by chapter two hundred ten of  
6 the private and special laws of nineteen hundred seven and  
7 as amended by chapter two hundred forty-two of the pri-  
8 vate and special laws of nineteen hundred nine, and as  
9 amended by chapter fifty of the private and special laws of  
10 nineteen hundred thirteen, is hereby further amended by  
11 inserting in line three thereof after the word "fifteen" the  
12 words and figures 'except so much of said lots numbered  
13 fourteen and fifteen as is embraced in the three following  
14 described deeds, to-wit: a deed from Austin M. Foss to

15 Frank W. Burns and Harry P. Burns dated May 1, 1906,  
16 and recorded in the Aroostook Registry of Deeds in Vol.  
17 221, Page 277; a deed from Osman D. Bean to Frank W.  
18 Burns and Harry P. Burns dated May 5, 1906, and recorded  
19 in said Registry of Deeds in Vol. 221, Page 294; and a deed  
20 from Albert R. Wellman, A. Pearl Wellman and Lizzie S.  
21 Robbins to Frank W. Burns dated March 29, 1909, and  
22 recorded in said Registry of Deeds in Vol. 238, Page 382,  
23 and the poll of the said Harry P. Burns,' so that said sec-  
24 tion as amended shall read as follows:

'Section 1. The following described territory: Lots num-  
26 bered two, except so much of said lot two as is now em-  
27 braced in the house lot of Augusta R. Rediker, three, ex-  
28 cept so much of said lot three as is now embraced in the  
29 farm of W. Holman Fisher, eight, nine, ten, except so much  
30 of said lot ten as lies west of a line extending northerly  
31 from the southeast corner of Gordon E. Boyer's house lot,  
32 parallel with the west line of said lot ten, to the north line  
33 thereof, eleven, twelve, thirteen, fourteen and fifteen, ex-  
34 cept so much of said lots numbered fourteen and fifteen  
35 as is embraced in the three following described deeds, to-  
36 wit: a deed from Austin M. Foss to Frank W. Burns and  
37 Harry P. Burns dated May 1, 1906, and recorded in the  
38 Aroostook Registry of Deeds in Vol. 221, Page 277; a deed  
39 from Osman D. Bean to Frank W. Burns and Harry P.  
40 Burns dated May 5, 1906, and recorded in said Registry of  
41 Deeds in Vol. 221, Page 294; and a deed from Albert R.

42 Wellman, A. Pearl Wellman and Lizzie S. Robbins to  
43 Frank W. Burns dated March 29, 1909, and recorded in  
44 said Registry of Deeds in Vol. 238, Page 382, and the  
45 poll of the said Harry P. Burns, and all of lot seventy-nine  
46 except that portion thereof on the northwesterly side of the  
47 Presque Isle road, so-called, and that portion thereof for-  
48 merly owned or occupied by George H. Churchill, in the  
49 town of Fort Fairfield, according to Sawyer's survey of  
50 township letter D. in the first range, together with the in-  
51 habitants therein, be and the same are hereby created a body  
52 politic and corporate by the name of the Fort Fairfield Vil-  
53 lage Corporation.'
