STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIFTEEN

AN ACT additional to chapter thirty-two of the Revised Statutes, as amended by chapter two hundred and six of the Public Laws of nineteen hundred and thirteen, relating to fishing in certain waters in Oxford County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No person shall fish for, take, catch or kill any
2 kind of fish at any time in any of the tributaries to Aziscohos
3 lake, or in any of the tributaries to Parmachenee lake, or in
4 any of the tributaries to the Magalloway river above Azis-
5 cohos dam, except Little Magalloway river below Wheeler
6 dam, all in the county of Oxford; nor shall any person fish

7 for, take, catch or kill any kind of fish at any time in Azis-
8 cohos lake or in Parmachenee lake or in Long pond or in
9 the Magalloway river above Aziscohos Dam, or in Little
10 Magalloway river below Wheeler Dam, which waters are
11 situated in Township Four, Range Five, W. B. K. P., other-
12 wise called Oxbow Town, Township Four, Range Six, W.
13 B. K. P. otherwise called Bowmantown, Township Five,
14 Range Five, W. B. K. P. otherwise called Parmachenee
15 Town, Township Five, Range Four, W. B. K. P. otherwise
16 called Lynchtown, Township Five, Range Three, W. B. K.
17 P. otherwise called Parkertown, and in Lincoln Plantation
18 and in Magalloway Plantation, all in the County of Oxford,
19 except by the ordinary method of casting with artificial flies
20 or fly fishing.

No person shall take, catch or kill in any one day, more than
22 five pounds of fish in all, or not more than ten fish, even
23 though the ten fish caught and killed weigh less than five
24 pounds in said Aziscohos lake, Parmachenee lake, Long pond.
25 the Magalloway river above Aziscohos Dam, or in Little
26 Magalloway river below Wheeler Dam, nor shall any person
27 have in possession in any one day more than five pounds of
28 fish in all, or not exceeding ten fish, even though they weigh
29 less than five pounds, taken in said waters.

No resident of this State shall carry away or transport in
31 any one day more than five pounds of fish, or not more than
32 one fish if it exceeds five pounds in weight, taken in any of
33 said waters: nor shall any non-resident carry away or trans-

34 port in any one day more than three pounds of fish, or not
35 more than one fish if it exceeds three pounds in weight,
36 taken in any of said waters, except that fish legally taken in
37 said waters may be transported from the place where caught
38 to a lodge, camp, dwelling house or hotel situated in the
39 above named territory.

No person shall have in possession at any time any kind of
41 fish taken in violation of any provision of this section.

Sect. 2. Whoever violates any provision of section one of
2 this act shall pay a fine of not less than ten dollars nor more
3 than thirty dollars and costs of prosecution for each offense ;
4 and in addition thereto one dollar for each fish taken, caught,
5 killed or had in possession in violation of any provision of
6 this act.
