STATE OF MAINE

RESOLVE in favor of Benjamin M. Jenness.

Resolved, That there be and is hereby appropriated the

- 2 sum of two hundred and forty-five dollars to be paid to Ben-
- 3 jamin M. Jenness for the burial of honorably discharged
- 4 soldiers of the War of 1861; namely thirty-five dollars each
- 5 for the burial of William Gilpatrick, Warren Thompson,
- 6 Charles W. Drummond, Thomas Banks, Horace T. Lang-
- 7 don, Frank Hamilton and Charles F. Sawyer.



STATEMENT OF FACTS.

All of the above named persons were honorably discharged soldiers of the War of 1861 and residents of the State at the time of their death and in destitute circumstances, having no kindred of sufficient ability, resident in this State, legally liable for their burial expenses. The claims were not paid by the Town of Sanford, in which said soldiers died, for the reason that the claims were not presented to the Municipal officers during the year in which the claims accrued.

William Gilpatrick was a member of Company K, 27th Maine Regiment, discharged July 17th, 1863, also of Company C, 30th Maine Regiment, discharged August 20, 1865. He died in Sanford, July 9th, 1905.

Warren Thompson was a member of Company , 8th Maine Regiment, discharged June 12, 1865. He died in Sanford, August 10th, 1908.

Charles W. Drummond was a member of Company D, 25th Infantry. He died in Sanford, Dec. 20th, 1908.

Thomas Banks was a Bugler in the 33rd Regiment, Massachusetts, and was in twenty-three battles. He died in Sanford, April 11th, 1909.

Horace T. Langdon was a member of Company G, 20th Massachusetts, discharged June 9th, 1865. He died in Sanford, June 21st, 1909.

Frank Hamilton was a member of Company D, 7th New Hampshire Volunteer Infantry. He died in Sanford, November 12th, 1909.

Chas. F. Sawyer was a member of Company I, 17th Maine Regiment, discharged June 4th, 1865. Died in Sanford, August 17th, 1910.
