STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend Chapter 481 of the Private and Special Laws of 1901 entitled "An Act to Incorporate York Harbor Village Corporation."

Be it enacted by the People of the State of Maine, as follows:

Section 4 of Chapter 481 of the Private and Special Laws

- 2 of 1901 entitled "An Act to Incorporate York Harbor Vil-
- 3 lage Corporation" is hereby stricken out and in lieu thereof
- 4 the following is substituted:
- 'Sect. 4. On or before the first day of July annually be-
- 6 ginning in 1915 the Town of York shall appropriate and pay
- 7 over to York Harbor Village Corporation a sum of money
- 8 computed as follows: From the annual appropriation raised

o by town taxation on the estates within said corporation for 10 the preceding year shall be deducted said corporation's pro-II portional part (based on valuation) of the whole annual 12 town levy for said preceding year for state, county and 13 school taxes, the salaries of town officers, and for reduction 14 of the town debt existing at the end of the fiscal year nine-15 teen hundred and fifteen and interest charges; and fifty-five 16 per centum of the sum thus determined, after also deducting 17 the corporation's proportion of town obligations for hy-18 drants and street lights, shall be said sum to be annually paid 19 over to said corporation as herein provided; but any sum so 20 determined shall not in any year exceed six thousand dol-21 lars. Said sum shall be expended by said corporation for its 22 corporate purposes and duties and payment thereof to the 23 corporation shall relieve said town of all town charges with-24 in said corporation except for street lighting, hydrant serv-25 ice, public schools and public health, maintenance of the 26 poor and the construction and repair of town sewers. 27 authority and duties of road commissioner within said cor-28 poration shall be exercised by said assessors; or they may 29 appoint an agent approved by the selectmen of said town 30 to perform the duties of road commissioner. In addition to 31 the power given by Section 6 of its charter the corporation 32 may from time to time borrow money as a temporary loan 33 in anticipation of the receipt of any annual town appropria-34 tion, or of its tax receipts."
