STATE OF MAINE

HOUSE OF REPRESENTATIVES, March 11, 1915.

Ordered, That the Clerk of the House be directed to prepare a schedule of Acts and Resolves carrying an appropriation or involving the expenditure of money, including all of such Acts and Resolves as have already received the signature of the Governor, such as have been reported to the House or Senate and such as are now pending before committees. Said schedule shall be printed and a copy thereof laid on the desk of each member on or before March 16th. The Clerk is authorized to procure and pay for any assistance necessary to the preparation of such a schedule, and the secretary of each committee is hereby instructed to forthwith prepare a statement of such work of his committee as would be of use in preparing such a schedule and file the same with the Clerk.
