5 ture of money, which had been signed by the Governor,  
6 which had been reported by the Committees and had not  
7 been finally passed, and which were still pending before the  
8 Committees up to March 15.

## STATEMENT OF FACTS.

Gardner K. Heath was authorized by the Clerk of the House to prepare the schedule according to the following order which was passed in the House on March 11, 1915.

### STATE OF MAINE.

House of Representatives,

March 11, 1915.

*Ordered*, That the Clerk of the House be directed to prepare a schedule of acts and resolves carrying an appropriation or involving the expenditure of money including all of such acts and resolves as have already received the signature of the Governor such as have been reported to the House or Senate and such as are now pending before the Committees.

Said schedule shall be printed and a copy thereof laid on the desk of each member on or before March 16.

The Clerk is authorized to procure and pay for any assistance necessary to the preparation of such a schedule and the Secretary of each Committee is hereby instructed to forthwith prepare a statement of such work of his Committee as would be of use in preparing such a schedule and file the same with the Clerk.
