STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend sections 36, 37 and 40 of chapter 29 of the revised statutes, relating to the manufacture and sale of intoxicating liquors, and particularly the manufacture and sale of cider.

Be it enacted by the People of the State of Maine, as follows:

Section I. Section thirty-six of chapter twenty-nine of

- 2 the revised statutes is hereby amended by striking out the
- 3 words "except cider" in the third line, so that said section
- 4 as amended shall read as follows:

'Sect. 36. Whoever manufactures for sale any intoxi-

- 6 cating liquor, except cider, and whoever sells any intoxi-
- 7 cating liquor manufactured by him in this state, shall be

- 8 imprisoned two months and fined one thousand dollars.'
 - Sect. 2. Section thirty-seven of chapter twenty-nine of
- 2 the revised statutes is hereby amended by striking out all
- 3 of said section after the word "cider" in the first line, and
- 4 inserting in place thereof the words 'containing at the time
- 5 of such sale not more than three per cent of alcohol;' so
- 6 that said section as amended shall read as follows:
- 'Sect. 37. This chapter does not apply to the sale of un-8 adulterated cider, containing at the time of such sale not
- o more than three per cent of alcohol.'
 - Sect. 3. Section forty of chapter twenty-nine of the re-
- 2 vised statutes is hereby amended by striking out the words
- 3 "kept or deposited with intent to sell the same for tippling
- 4 purposes or as a beverage" in the fourth and fifth lines of
- 5 said section, and inserting in place thereof the words 'con-
- 6 taining more than three per cent of alcohol' so that said
- 7 section as amended shall read as follows:
- 'Sect. 40. No person shall at any time, by himself, his
- 9 clerk, servant or agent, directly or indirectly, sell any intox-
- 10 icating liquors, of whatever origin, except as hereinbefore
- 11 provided; wine, ale, porter, strong beer, lager beer and all
- 12 other malt liquors, and cider when containing more than
- 13 three per cent alcohol, as well as all distilled spirits, are
- 14 declared intoxicating within the meaning of this chapter,
- 15 but this enumeration shall not prevent any other pure or
- 16 mixed liquors from being considered intoxicating."
