#### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend section thirty-nine of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred and six of the Public Laws of nineteen hundred and thirteen, relating to the protection of beaver.

Be it enacted by the People of the State of Maine, as follows: Section thirty-nine of chapter thirty-two of the Revised

- 3 Public Laws of nineteen hundred and thirteen, relating to
- 4 the protection of beaver, is hereby amended by striking out
- 5 all of said section and substituting therefor the following
- 6 section:

The commissioners of inland fisheries and game, 8 upon written complaint of any land owner that beaver are o doing actual, substantial damage to his property, shall have 10 authority to declare an open season for beaver upon such 11 land for such period of time as they may deem necessary to 12 remove the beaver that are doing the damage complained of, 13 during which open season it shall be lawful for any licensed 14 hunter and trapper of fur bearing animals to trap beaver 15 thereon. No open season for beaver as contemplated by 16 this section shall take effect until the commissioners of in-17 land fisheries and game shall have caused notice of such 18 proposed open season to be published one time in a news-19 paper printed in the county in which the land on which the 20 open season for beaver is declared is located, and said com-21 missioners shall also file copy of said notice of open season 22 with the clerk of the town or plantation in which such land 23 is located, or if the land is in an unorganized place, with the 24 clerk of courts for the county in which the land is located.

Whenever during a special open season on beaver as is 26 contemplated by this section it shall appear to the commis-27 sioners of inland fisheries and game that the privileges of 28 such open season are being abused in any place, said commis-29 sioners of inland fisheries and game may suspend the open 30 season and declare it close season for beaver on such land 31 for such time as they may designate.

It shall be unlawful to take any beaver anywhere in the 33 state at any time except during such open season as may be 34 declared by the commissioners of inland fisheries and game35 in accordance with the provisions of this section.

Whoever takes any beaver in violation of any of the pro-37 visions of this section shall be subject to a penalty of twenty-38 five dollars and costs for each beaver taken, caught or killed 39 in violation of any provision of this section. It shall also be 40 unlawful, under the same penalty, for any person to have in 41 possession at any time, any beaver, or part thereof, taken 42 in violation of any provision of this section.'
