STATE OF MAINE

AN ACT to amend Section 5 of Chapter 44, Public Laws of 1907 as amended by Chapter 167, Public Laws of 1909, relating to commitment to Maine School for Feeble Minded.

Be it enacted by the People of the State of Maine, as follows:

Section 5 of chapter 44, public laws of 1907 as amended by

2 chapter 167, public laws of 1909, is hereby further amended

3 by striking out in the ninth line thereof the words "trustees

4 of said school for feeble minded" and inserting in place

5 thereof the words 'hospital trustees,' and by inserting after

6 the word "institution" in the thirteenth line thereof, the fol
7 lowing: 'provided no such order of commitment shall issue

8 until an application for admission of such person has first

9 been made to the Hospital Trustees, which shall be placed

10 on file at the institution and evidence thereof presented to

11 the Judge of Probate, accompanied by a certificate of the

12 superintendent, stating, in substance, that such person will 13 be received under the provisions of section 7, chapter 44 of 14 the public laws of 1907 when properly committed,' so that 15 said section, as amended, shall read as follows:

'Sect. 5. Whenever it is made to appear, upon application 17 to the judge of probate for any county and after due notice 18 and a proper hearing, that any person resident in said county, 19 or any inmate of the Maine industrial school for girls, the 20 state school for boys, the Bath military and naval orphan 21 asylum, or any person supported by any town, is a fit sub-22 ject for the Maine School for Feeble Minded, such judge 23 may commit such person to said school by an order of com-24 mitment directed to the Hospital Trustees, accompanied by a 25 certificate of two physicians who are graduates of some le-26 gally organized medical college and have practiced three 27 years in this state that such a person is a proper subject for 28 said institution; provided no such order of commitment shall 29 issue until an application for admission of such person has 30 first been made to the Hospital Trustees, which shall be 31 placed on file at the institution and evidence thereof pre-32 sented to the Judge of Probate, accompanied by a certificate 33 of the superintendent, stating in substance that such person 34 will be received under the provisions of section 7, chapter 35 44 of the public laws of 1907 when properly committed. 36 Whenever, upon such application, there is occasion for the 37 judge of probate to attend a hearing on days other than days 38 fixed as the regular day for holding the probate court, said 39 judge of probate shall be allowed five dollars per day for his 40 services and expenses, which shall be paid by the county 41 treasurer upon the certificate of the county commissioners.'
