STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend Section 1, Chapter 60, of the Revised Statutes as amended by the Public Laws of 1909, Chapter 98, relating to the appointment of the Commissioner of Agriculture.

Be it enacted by the People of the State of Maine, as follows:

Chapter 60, section 1, of the revised statutes as amended

- 2 by the public laws of 1909, chapter 98, is hereby amended
- 3 by striking out the second sentence thereof which reads:
- 4 "A commissioner of agriculture shall be elected biennially
- 5 by the legislature by joint ballot of the senators and repre-
- 6 sentatives in convention, and shall hold his office for the
- 7 term of two years and until his successor is elected and

8 qualified," and substituting therefor the following: 'A com-9 mittee consisting of the master of the Maine State Grange, 10 the president of the Maine Pomological Society, the presi-II dent of the Maine Dairymen's Association, the president 12 of the Maine Seed Improvement Association, the president 13 of the Maine Livestock Breeders' Association, the dean of 14 the College of Agriculture of the University of Maine, and 15 the director of the Maine Agricultural Experiment Station, 16 shall, prior to January 1, 1917, and thereafter whenever 17 a vacancy exists in the office of commissioner of agriculture, 18 select and present to the governor the name of a person in 19 their opinion qualified to fill the office of commissioner of 20 agriculture who shall in the month of January, 1917, and 21 thereafter whenever a vacancy exists be appointed by the 22 governor the commissioner of agriculture, and said com-23 missioner shall hold his office for the term of six years and 24 until his successor is appointed and qualified.' So that the 25 whole section as amended shall read as follows:

'Section I. A state department of agriculture shall be 27 maintained for the improvement of agriculture and the 28 advancement of the interests of husbandry. A committee 29 consisting of the master of the Maine State Grange, the 30 president of the Maine Pomological Society, the president 31 of the Maine Dairymen's Association, the president of the 32 Maine Seed Improvement Association, the president of the 33 Maine Livestock Breeders' Association, the dean of the 34 College of Agriculture of the University of Maine, and the

35 director of the Maine Agricultural Experiment Station, 36 shall, prior to January 1, 1917, and thereafter whenever 37 a vacancy exists in the office of the commissioner of agri-38 culture, select and present to the governor the name of a 39 person in their opinion qualified to fill the office of com-40 missioner of agriculture who shall in the month of Jan-41 uary, 1917, and thereafter, whenever a vacancy exists, be 42 appointed by the governor the commissioner of agriculture, 43 and said commissioner shall hold his office for the term of 44 six years and until his successor is appointed and qualified. 45 He shall give bond in the sum of ten thousand dollars to 46 the state, with sufficient sureties to be approved by the 47 treasurer of state, conditioned to faithfully account for all 48 moneys received and disbursed by him as said commissioner. 49 He shall by personal observation, investigation and corre-50 spondence, acquaint himself with the methods and wants 51 of practical husbandry, the means of fertilization, and the 52 adaptation of various products to the soils and climate of 53 Maine; also with the progress of scientific and practical 54 agriculture elsewhere, with a view to the more complete 55 development of the natural resources of the state. The 56 commissioner of agriculture shall gather statistics of in-57 formation concerning agriculture and publish the same an-58 nually; he shall assist the farmers of the state, in so far as 59 is practical, to secure farm help, and to promote increased 60 production of farm crops through the selection, the grow-61 ing and the dissemination of superior strains of seeds. An 62 appropriation of three thousand dollars annually shall be
63 made, to be expended by the commissioner of agriculture
64 for the purpose of carrying out the provisions of this sec65 tion and section five of chapter sixty of the revised stat66 utes, and for such other purposes and in such manner as
67 in his judgment will best promote the interests of agri68 culture in this state.'
