STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND FIFTEEN

AN ACT to amend section 51 of chapter 32 of the revised statutes, as amended by chapter 206 of the public laws of nineteen hundred and thirteen, relating to non-resident hunting licenses.

Be it enacted by the People of the State of Maine, as follows:

Section fifty-one of chapter thirty-two of the revised stat-2 utes, as amended by chapter two hundred and six of the 3 public laws of nineteen hundred and thirteen, is hereby 4 amended by striking out all of said section and by substi-

'Sect. 51. Persons not bona fide residents of the state, 7 and actually domiciled therein, shall not hunt, pursue, take

5 tuting therefor the following section:

8 or kill any deer, ducks, partridges, woodcock, or other wild 9 birds or wild animals, or have the same, or any part 10 thereof, in possession, at any time without first having pro11 cured a license therefor as hereinafter provided.

Such licenses shall be issued by the commissioners of in-13 land fisheries and game, upon application in writing and 14 payment of fifteen dollars to hunt deer, ducks, partridges, 15 woodcock and other birds and wild animals during their 16 respective open seasons, and in the manner provided by 17 law, in October, November and December. But to hunt, 18 in their respective open seasons, and in the manner pro-19 vided by law, ducks, partridges, woodcock and other birds 20 and wild animals in the counties of Aroostook, Washing-21 ton, Hancock, Penobscot, Piscataquis, Somerset, Franklin 22 and Oxford up to October first of each year a license fee 23 of five dollars shall be paid annually: provided, further, 24 that in the counties of Androscoggin, Cumberland, Knox, 25 Kennebec, Lincoln, Sagadahoc, Waldo and York such per-26 son may procure a license for five dollars to hunt, in their 27 respective open seasons and in the manner provided by law 28 ducks, partridges, woodcock and other birds and wild ani-29 mals except during open season on deer in said counties. A 30 person having paid the fee of five dollars may procure a li-31 cense to hunt deer and other wild animals and wild birds, in 32 their respective open seasons and in the manner provided by 33 law, during the open season on deer by paying an additional 34 fee of ten dollars.

Such license shall entitle the purchaser to take to his home, 36 in addition as now provided, properly tagged with a tag 37 detached from his license, and open to view, five partridges, 38 ten ducks and ten woodcock that he has himself lawfully 39 killed, and under such rules and regulations to be establed lished by the commissioners as may be required to carry out the true intent of this chapter and not inconsistent here-

Each license shall be provided with two coupons, each of 44 which shall permit the transportation of the carcass of one 45 deer, or part thereof, and shall be divided into two sections 46 each, lettered "A" and "B" and "C" and "D" respectively, 47 and shall be called the deer coupons.

The holder of a non-resident hunter's license shall be en49 titled to offer for transportation and have transported,
50 within or without this State by any railroad company, ex51 press company, boat or other transportation company, the
52 carcass of one deer, or part of the carcass of one deer,
53 that he himself has lawfully killed, on each of the deer
54 coupons attached to his said license, by presenting to the
55 agent of any transportation company his license, with the
56 coupons attached to the license at the time when he shall of57 fer the deer for shipment. If but one deer is offered for ship58 ment the agent shall detach section "A" from the first
59 "deer" coupon of the license, cancel the same by writing
60 or stamping thereon the date and place of shipment and
61 his name, and shall forward the same forthwith to the com-

62 missioners of inland fisheries and game, at Augusta, Maine, 63 section "B" of said coupon shall be likewise canceled and 64 shall be attached to the carcass, or part of the carcass of 65 the deer offered for shipment and shall remain attached to 66 the same while it is being transported in this state.

In case two deer are offered for shipment the agent re68 ceiving the same for shipment shall detach sections "A" and
69 "C" from the "deer" coupons and after canceling the same
70 shall forward them to the commissioners as aforesaid, and
71 sections "B" and "D" shall be likewise canceled and at72 tached to the carcass of the deer, or parts thereof, offered
73 for shipment, and shall remain attached to the same while
74 it is being transported in this State.

No person shall transport any deer, or part thereof, for 76 any non-resident, otherwise than as provided herein. No 77 agent, servant or employee of any transportation company, 78 railroad company, express company, boat or common carrier shall receive for shipment or transport, or have in his 80 possession with intent to ship or transport any carcass of 81 a deer, or part of the same, or any game birds, for a non-82 resident, except as herein provided, or refuse or neglect to 83 detach the sections of the coupons as herein provided, or 84 fail to forward to the commissioners of inland fisheries and 85 game, at Augusta, Maine, as herein provided, the sections 86 of coupons by him detached; provided, however, that any 87 person who has purchased a non-resident hunter's license 88 and who has lawfully in his possession one pair of game

89 birds, may transport the same to his home or to any hos-90 pital in this state without accompanying the shipment, by 91 purchasing of the duly constituted agent therefor a tag, 92 paying for the same fifty cents, and by presenting said tag 93 with the pair of game birds offered for shipment to the 94 agent of any transportation company or common carrier, to-95 gether with his non-resident hunter's license.

Before accepting a pair of game birds for shipment as 97 herein provided, the agent of the transportation company or 98 common carrier to whom the same is offered for shipment 99 shall be satisfied that the person presenting the pair of game 100 birds for shipment is the person to whom the non-resident 101 hunter's license offered for inspection was issued, and 102 shall securely affix the tag to such shipment; provided, 103 further, that no person shall send more than one pair of 104 game birds under special tag, as provided herein, but once 105 in thirty days.

Whoever violates any provision of this section, or who 107 shall furnish to another person, or permits another person 108 to have or use any license or coupon issued to him or 109 change or alter the same in any manner, or who has or used 110 any license or coupon issued to another person, or any reg111 istered guide, who knowingly guides any non-resident in 112 hunting who has not a license to hunt as herein provided, 113 shall pay a fine of not less than twenty-five nor more than 114 one hundred dollars and costs, for each offense.'
