AN ACT to amend Chapter four hundred and eighty-nine of the Private and Special Laws of nineteen hundred and one, entitled "An Act to Supply the Town of Lubec with Pure Water."

---

*Be it enacted by the People of the State of Maine, as follows:*

Section six of chapter four hundred and eighty-nine of the  
2 private and special laws of nineteen hundred and one is  
3 hereby amended by inserting after the words "three years"  
4 in the tenth line of said section the words, 'should a vacancy  
5 occur in said board of water commissioners by death, resig-  
6 nation or otherwise of any or all of said water commission-  
7 ers, the selectmen of said town of Lubec may fill the vacancy

8 thus caused by appointment to fill the unexpired term, said  
9 appointment or appointments shall be in writing and record-  
10 ed in the town record book of Lubec where the names of  
11 other town officials are recorded,' so that said section, as  
12 amended, shall read as follows:

'Sect. 6. For the purpose of carrying into effect the pro-  
14 visions of this act, the town of Lubec, at a meeting duly  
15 called therefor, may, as soon as this act takes effect, and  
16 shall, as soon as the town comes into ownership, control or  
17 management of a system of water works, by building, pur-  
18 chase, or otherwise, elect by ballot three water commission-  
19 ers, the three first chosen as aforesaid, shall serve, one for  
20 one year, one for two years, and one for three years; should  
21 a vacancy occur in said board of water commissioners by  
22 death, resignation or otherwise or any or all of said board  
23 the selectmen of said town of Lubec shall fill the vacancy  
24 or vacancies thus caused by appointment to fill the unex-  
25 pired term or terms, said appointment or appointments shall  
26 be in writing and recorded in the town record book of Lu-  
27 bec where the names of other town officers are recorded.  
28 Said commissioners are authorized to fix the water rates  
29 and determine the conditions and the manner of water sup-  
30 ply, and shall have the general control and management of  
31 the water system owned by the town. They shall receive  
32 such compensation for their services as may be fixed by the  
33 town.'
