## STATE OF MAINE

AN ACT to amend Section 5 of Chapter 44, Public Laws of 1907 as amended by Chapter 167, Public Laws of 1909 relating to commitment to Maine School for Feeble Minded.

Be it enacted by the People of the State of Maine, as follows:

Section 5 of Chapter 44, Public Laws of 1907 as amended 2 by Chapter 167, Public Laws of 1909, is hereby further 3 amended by striking out in the ninth line thereof the words 4 "trustees of said school for feeble minded" and inserting in 5 place thereof the words 'hospital trustees,' and by inserting 6 after the word "institution" in the thirteenth line thereof, 7 the following: 'provided no such order of commitment shall 8 issue until an application for admission of such person has 9 first been made to the Hospital Trustees, which shall be 10 placed on file at the institution and evidence thereof pre-

11 sented to the Judge of Probate, accompanied by a certificate

12 of the superintendent stating, in substance, that such person 13 will be received under the provisions of Section 7, Chapter 14 44 of the Public Laws of 1907 when properly committed,' 15 so that said section, as amended, shall read as follows:

'Sect. 5. Whenever it is made to appear, upon application 17 to the judge of probate for any county and after due notice 18 and a proper hearing, that any person resident in said 19 county, or any inmate of the Maine industrial school for 20 girls, the state school for boys, the Bath military and naval 21 orphan asylum, or any person supported by any town, is a 22 fit subject for the Maine School for Feeble Minded, such 23 judge may commit such person to said school by an order of 24 commitment directed to the Hospital Trustees, accompanied 25 by a certificate of two physicians who are graduates of some 26 legally organized medical college and have practiced three 27 years in this state, that such a person is a proper subject for 28 said institution; provided no such order of commitment shall 20 issue until an application for admission of such person has 30 first been made to the Hospital Trustees, which shall be 31 placed on file at the institution and evidence thereof pre-32 sented to the Judge of Probate, accompanied by a certificate 33 of the superintendent, stating in substance that such person 34 will be received under the provisions of Section 7. Chapter 35 44 of the Public Laws of 1907 when properly committed. 36 Whenever, upon such application, there is occasion for the 37 judge of probate to attend a hearing on days other than 38 days fixed as the regular day for holding the probate court.

39 said judge of probate shall be allowed five dollars per day 40 for his services and expenses, which shall be paid by the 41 county treasurer upon the ecrtificate of the county commis-42 sioners.'
