STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to amend sections thirty-five and thirty-eight of chapter 45 of the Revised Statutes of 1916, relating to the measurement of lobsters.

Be it enacted by the People of the State of Maine, as follows:

- Section 1. That all of section thirty-five of chapter 45 of
- 2 the Revised Statutes of 1916 between the words, "no person"
- 3 and the words, "The possession" be stricken out, and that
- 4 there be inserted the following: 'shall buy or sell, give away
- 5 or expose for sale or possess for any purpose any lobster,
- 6 which is less than four and one-eighth inches or more than

7 six inches in length, alive or dead, cooked or uncooked, 8 measured in manner as follows: Taking the length of the 9 back of the lobster measured from the end of the bone of 10 the nose to the center of the rear end of the body shell, 11 and any lobster shorter or longer than the prescribed lengths 12 when caught shall be immediately liberated alive at the risk 13 and cost of the parties taking them, under a penalty of five 14 dollars for each lobster caught, bought, sold, given away or 15 exposed for sale, measuring more or less than the prescribed 16 lengths or in possession contrary to the provisions hereof; 17 so that said section as amended shall read as follows:

'Sect. 35. No person shall buy or sell, give away or ex-2 pose for sale or possess for any purpose any lobster, which 3 is less than four and one-eighth inches or more than six in 4 length, alive or dead, cooked or uncooked, measured in man-5 ner as follows: Taking the length of the back of the lobster 6 measured from the end of the bone of the nose to the center 7 of the rear end of the body shell, and any lobster shorter 8 or longer than the prescribed lengths when caught shall be 9 immediately liberated alive at the risk and cost of the parties 10 taking them, under a penalty of five dollars for each lobster 11 caught, bought, sold, given away or exposed for sale, meas-12 uring more or less than the prescribed lengths or in posses-13 sion contrary to the provisions hereof; The possession of 14 mutilated lobsters, cooked or uncooked, shall be prima facie 15 evidence that they are not of the required length. All lob-16 sters or parts of lobsters sold for use in this state or for

17 export therefrom must be sold and delivered in the shell un-18 der a penalty of twenty dollars for each offence, and who-19 ever ships, transports, carries, buys, gives away, sells or ex-20 poses for sale lobster meat after the same shall have taken 21 from the shell shall be liable to a penalty of one dollar 22 for each pound of meat so shipped, transported, carried, 23 bought, given away, sold or exposed for sale. Any person 24 or corporation in the business of a common carrier of mer-25 chandise, who shall knowingly carry or transport from place · 26 to place lobster meat after the same shall have been taken 27 from the shell shall be liable to a penalty of fifty dollars 28 upon each conviction thereof. All lobster meat so illegally 29 shipped, transported, carried, bought, given away, sold or 30 exposed for sale shall be liable to seizure and may be con-31 fiscated. Nothing contained herein shall be held to prohibit 32 the sale of lobsters that have been legally canned.'

Sect. 2. That all of Section thirty-eight of Chapter 45 of 2 the Revised Statutes of 1916 between the words "No Per-3 son" and the words "and for every lobster," be stricken out, 4 and that there be inserted the following: 'shall can lobsters 5 less than four and one-eighth inches or more than six inches 6 in length, alive or dead, measured in accordance with Section 7 thirty-five of Chapter 45 of the Revised Statutes': and that 8 the words "one dollar" be stricken out and that there be 9 inserted the words 'five dollars'; so that said section as 10 amended shall read as follows:

'Sect. 38. No person shall can lobsters less than four and 2 one-eighth inches or more than six inches in length, alive 3 or dead, measured in accordance with Section thirty-five of 4 Chapter 45 of the Revised Statutes; and for every lobster 5 canned contrary to the provisions of this section, every per-6 son, firm, association or corporation so canning shall be lia-7 ble to a penalty of five dollars for every lobster so canned 8 contrary to the provisions of this section, and a further pen-9 alty of three hundred dollars for every day on which such 10 unlawful canning is carried on.'
