### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT authorizing Fort Kent Electric Company, its successors and assigns, to erect and maintain a dam across Wallagrass stream in Wallagrass Plantation, Aroostook county, at its power station as now located on said Wallagrass stream.

Be it enacted by the People of the State of Maine, as follows: Section 1. Fort Kent Electric Company, a corporation

- 2 organized by law and located at Fort Kent in the county of
- 3 Aroostook and State of Maine, is hereby authorized to erect,
- 4 construct and maintain a dam across Wallagrass stream in
- 5 Wallagrass Plantation in said county of Aroostook, or main-

6 tain the dam of said electric company already erected, at or 7 near its power plant as now located on said Wallagrass 8 stream, for the purpose of furnishing water power to be used 9 for any of the purposes for which said Fort Kent Electric 10 Company is organized.

Sect. 2. For the aforesaid purposes said company may 2 raise and maintain said dam to a height to enable it at all 3 times to obtain a sufficient head of water on said Wallagrass 4 stream for the proper and efficient operation of its said 5 power plant.

Sect. 3. Said company shall construct and maintain 2 proper and suitable sluiceways to allow the free passage of 3 logs and lumber, which sluiceways shall be at the disposal of 4 all persons driving said stream without any charge for tolls, 5 provided that at all times said company shall have the right 6 to refuse to permit the use of said sluiceways when the flow 7 of water in said stream is such that the use of said sluice-8 ways will prevent said company from holding a sufficient 9 head of water for the proper operation of its said power 10 plant.

Sect. 4. All persons damaged in their property rights by 2 reason of the rights granted said company by this act shall 3 be entitled to have their damages assessed by the county 4 commissioners of Aroostook county, in the same manner as 5 is provided by law for the assessment of damages for the 6 laying out of highways.
